May kindly see the letter dated 30.3.17 (at flag 'A') of Sri Vijai Kumar Azad, Chief Judicial Magistrate, Sultanpur by which he has submitted his Statements of movable and immovable property for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2014-15, Sri Azad's total Income from Salary and other Sources is Rs.20,99,392/- (Rs.12,75,164/- from gross Salary, Rs.1,57,536/- from maturity of FDR, Rs.63,556/- from interest of S.B. A/c and other, Rs.20,000/- from Agriculture, Rs.5,83,136/- from maturity of LICs) from this amount, he has paid Rs.87,656/- against GPF, Rs.4800/- against GIS, Rs.1,71,515/-, Rs.24,000/- against R.D., Rs.1,50,000/- against PPF, Rs.1,99,500/- against Insurances. As such, total deductions /Savings/investment is Rs.6,37,471/-. The balance of his Saving Bank Account(s) has decreased for Rs.32,218/- this financial year. Thus a sum of Rs.14,94,139/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the Calendar year 2014-15.

(2) In the statement of movable and immovable property for the financial year 2015-16, Sri Azad's total Income from Salary and other Sources is Rs.14,58,592/- (Rs.12,65,434/- from gross Salary, Rs.7378/- from interest of S.B. A/c and other, Rs.40,000/- from Agriculture, Rs.1,45,780/- from maturity of R.D.) from this amount, he has paid Rs.76,459/- against GPF, Rs.4800/- against GIS, Rs.1,50,282/- against Income Tax, Rs.6,000/- against R.D., Rs.1,50,000/- against PPF, Rs.1,99,500/- against Insurances. As such, total deductions /Savings/investment is Rs.5,87,041/-. The balance of his Saving Bank Account(s) has decreased for Rs.1,22,602/- this financial year. Thus a sum of Rs.9,94,153/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the Calendar year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 30.3.17^(flag 'A') was due to be submitted in the financial year 2016-17. As such there is no delay in submitting the Property statements for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Azad has already submitted his property statement upto financial year 2013-14 which was seen by . . . 2
