May kindly see the letters dated 16.10.2018 (at flag 'A') of Sri Vijay Kumar Azad, Additional District and Sessions Judge/FTC, Balrampur by which he has submitted his Statement of movable and immovable property for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2016-17, Sri Azad's Gross Salary is Rs.12,44,106/- from this amount, he has paid Rs.69559/- against GPF, Rs.4400/- against GIS, Rs.1,62,051/- against Income Tax, Rs.30,000/- against R.D., Rs.1,50,000/- against PPF, Rs.229599/- against LIC. As such, total deductions/Saving/ investment is Rs.6,45,609/-. The balance of his Saving Bank Accounts(s) decreased for Rs.95,206/- in this financial year against his balance of previous years. Thus a sum of Rs.6,93,703/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.

(2) In the statement of movable and immovable property for the financial year 2017-18, Sri Azad's Gross Salary is Rs.17,16,340/- from this amount, he has paid Rs.80,550/- against GPF, Rs.5200/- against GIS, Rs.2,97,200/- against Income Tax, Rs.60,000/- against R.D., Nil against PPF, Rs.2,29,599/- against LIC. The balance of his Saving Bank Accounts(s) enhanced for Rs.1,23,501/- in this financial year against his balance of previous years. As such, total deductions/Saving/ investment is Rs.7,96,050/-. Thus a sum of Rs.9,20,290/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

In this connection it is submitted that Sri Azad had already submitted the statement of his property acquired/held upto the financial year 2015-16, which has already been seen by the Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Sultanpur judgeship on 4.7.2017 which is at flag 'Z' and said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 16.10.2018 (flagged 'A') which was due to be submitted in the third financial years 2018-19. As such there is no delay in submitting the aforesaid Property statements from the part
