May kindly have the perusal of letter no. 1221/II, dated 25.09.2017 (at flag 'A') of the Additional District Judge-Fast Track Court/ D.D.O., Rampur for making payment of 90% amount of the balance, available in G.P. Fund Account No.L.J.U.-24444 of Sri Ram Swaroop Saroj, Retired Additional District Judge, Rampur.

Sri Ram Swaroop Saroj retired from the post of Additional District Judge, Rampur after attaining the age of superannuation on 31.07.2017.

The Additional District Judge-Fast Track Court/ D.D.O., Rampur through his afore-mentioned letter has submitted original Pass-Book of G.P.Fund Account No.L.J.U.-24444 (at flag 'B') along with three sets of application in Form 425-A under the signature and seal of DDO for the District Judge, Rampur as well as Chief Treasury Officer, Rampur together with three sets of calculation sheets prepared for the financial year 2012-13, 2013-14, 2014-15, 2015-16, 2016-17 & 2017-18 (at flags 'C', 'D', 'E', 'F', 'G' and 'H') and attested copy of Reconciliation Certificate, issued by the A.G.(A.&E.)-II, U.P., Allahabad on 05.06.2017 (at flag 'I') of Sri Ram Swaroop Saroj. The DDO for the District Judge, Rampur has also requested the Court, for sanctioning payment of 90% amount of G.P. Fund to Sri Ram Swaroop Saroj from his G.P.Fund Account No.L.J.U.-24444.

As per Reconciliation Certificate issued from the A.G.(A.&E.)-II, U.P., Allahabad a total of Rs.28,47,980/- is available as closing balance of Financial Year 2015-2016 in G.P.F. Account No.L.J.U.-24444 and the same has been considered as opening amount for the Financial Year 2016-17 in the G.P.Fund Pass-Book, which has been verified by the DDO for the District Judgeship, Rampur. Further, from perusal of G.P.F. pass-book and calculation sheets of the Financial Year 2016-17 and 2017-2018, it is evident that the following amount was credited in respective manner :

Going further, it is submitted that out of the total amount of Rs.34,27,213/-, the DDO for the District Judgeship, Rampur has recommended for

sanction of Rs.30,84,492/- (Thirty Lakhs Eighty-four Thousand Four hundred and Ninety-two only) in favour of Sri Ram Swaroop Saroj as 90% amount of his G.P.Fund in the Drawing and Disbursing Part (at flag 'K') of his application in Form 425-A. The Chief Treasury Officer, Rampur has also recommended, for making payment of the same amount i.e., Rs.30,84,492/- (Thirty Lakhs Eighty-four Thousand Four hundred and Ninety-two only) at the place of Checking Accounts Authority Part of his application in Form 425-A after checking calculation sheets of G.P. Fund of Sri Ram Swaroop Saroj.

In this context it is submitted that the payment of 90% of G.P.Fund amount of Retiring/Retired Judicial Officer is to be sanctioned by this Court in terms of G.O.No.Sa-4-A.G.-57/X-84-510-84, dated 26.12.1984 and General Provident Fund (Uttar Pradesh)(Second Amendment) Rules, 2000 on submission of Reconciliation Certificate, issued by the office of the A.G.(A.&E.)-II, U.P., Allahabad, G.P. Fund Pass-Book of Retiring/Retired Judicial Officer prepared at least from the financial year 1985-86 up to the month of his retirement and calculation sheets of his G.P.Fund of the current financial year (up to the month of retirement) as well as preceding five financial years to this Court by the Drawing and Disbursing Officer of concerned Establishment/Judgeship with his recommendation and recommendation of the Chief/Senior Treasury Officer of the District, for payment of 90% of G.P.Fund amount to the Retiring/Retired Judicial Officer.

After perusal of G.P. Fund Pass-Book of Sri Ram Swaroop Saroj, it appears that Final Withdrawal and Temporary Advance are nil.

In view of the facts, mentioned above, if approved by the Learned Registrar (Judicial) (Budget), the file may be laid before Hon'ble Mr. Justice Manoj Misra, "Nominated Judge for disposal of the matters of Judicial Officers for payment of 90% amount of G.P.Fund," for His Lordship's kind perusal and order to the effect that a sum of Rs.30,84,492/- (Thirty Lakhs Eighty-four Thousand Four hundred and Ninety-two only) may be sanctioned to Sri Ram Swaroop Saroj, Retired Additional District Judge, Rampur as 90% amount of the total balance available in his G.P. Fund Account No.L.J.U.-24444, up till the date of his retirement from service i.e. 31.07.2017, subject to the condition that in case of over payment, if any, reported later on, by office of the Accountant General (A.&E.)-II, U.P., Allahabad, he shall refund the excess payment along with amount of interest accrued thereon in lump sum within a month?

His Lordship may also be requested kindly to sign the draft sanction order, placed, at the place cross marked with red pen?
