So far as the date of promotion of the abovenamed officers is concerned, it may be mentioned that the Hon'ble Court has been pleased to consider the matter and resolve that the male candidates be given notional fixation in accordance with the equalization principle so that they may draw salary at par with the women candidates. The Hon'ble Court has clarified that for the period during which male officers have not worked, they will not be entitled for any salary.

I am, therefore, to request you to kindly take necessary steps in the matter for fixing the pay of above mentioned 11 men officers for equalizing the pay at par with the women candidates who have been placed immediately junior to them and issue the pay authority slip accordingly.
