May kindly see letter dated 20.11.18(at flag 'A') of Sri Arvind Kumar Mishra-II, Special Secretary and Additional L.R, Government of U.P., Lucknow regarding inclusion of LL.M qualification in his service records and ensuant grant of three advance increments.

Vide aforesaid letter, Sri Arvind Kumar Mishra-II has informed that he completed LL.M course in year 1996 from Banaras Hindu University, Varanasi and has thus requested for inclusion of said qualification. In support of same, he has submitted attested copies of degree and mark-sheets of LL.M.

In this context it is submitted that Sri Arvind Kumar Mishra-II joined U.P.Nyayik Sewa on 31.05.2003. As apparent from submitted copies of mark-sheets and degree(at flags 'B1', 'B2' & 'B3'), Sri Arvind completed LL.M course in year 1996 from Banaras Hindu University i.e prior to entering into U.P.J.S. However, he did not mention this detail in his application form of U.P.Nyayik Sewa, therefore said qualification is now ought to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P thus qualification of LL.M. may be included in the service records of Sri Arvind Kumar Mishra-II with the permission of Government of U.P., Lucknow. Besides, it is submitted that benefits of three advance increments can be granted only after inclusion of qualification of LL.M in service records of concerned officer. Therefore, it seems proper that aforesaid representation dated 20.11.18(flagged as 'A') of Sri Arvind Kumar Mishra-II, Special Secretary and Additional L.R, Government of U.P., Lucknow may be sent to the Government of U.P. for obtaining necessary orders, so that same may be subsequently placed before appropriate authorities for grant of three advance increments.

In the view of above submissions, if approved by Hon'ble Mr. Justice Bala Krishna Narayana, Administrative Judge, Lucknow, copy of aforesaid letter dated
