May kindly see the letter, placed below at flag 'A'; received from Sri Chandra Shekhar, the then Additional Civil Judge (Sr. Div.), Varanasi now posted as Civil Judge (Sr. Div.) Kairana, Muzaffarnagar by which he has furnished the reply, in compliance of order of Hon'ble Mr. Justice Sanjay Misra, the then Administrative Judge, Varanasi in the matter of Property Statement, communicated to the officer vide Court's letter dated 30-01-2012.

In this connection, it is submitted that earlier Sri Chandra Shekhar had submitted his consolidate movable & immovable property statements for the financial year 2004-05, 2005-06, 2006-07 and 2007-08 which was put up before Hon'ble Justice Sanjai Misra, the then Administrative Judge, Varanasi through office note dated 29-09-11 (Flagged 'BB') on which his Lordship has been pleased to pass the following order-

" Obtain details of re-payment of car loan taken from SBI in 2006-2007."

The order of the Court had been communicated to the officer concerned vide Court's letter dated 30-01-2012 (flagged 'DD'). In the mean time Sri Chandra Shekhar has submitted the property statement of the financial year 2008-09 & 2009-10 through his letter dated 02-05-12 (flagged 'X') but no reply received about the Court's letter 30-01-12. Thereafter a letter dated 06-06-12 ('Y') was again sent to the officer concerned

Now in reply of the Court's letter ^{dt. 30.1.12} and in compliance of Court's Order the officer has sent his reply vide his letter dated 2.5.12 (flagged 'X'). Then office has sent a letter dated 23.7.12 (flagged 'C') to the officer to submit his property statement for the financial years 2008-09 and 2011-12 as the same was also due to be submitted.

In reply of aforesaid Court's letter, Officer has submitted his property statement for the financial years 2008-09 only and has stated that he has yet not received the details of movable and immovable property for the financial year 2011-12 as his father died and the paternal property is still not divided, the division is still pending between his brothers. He has further informed that after receiving the detail of paternal property he will inform to this Court without making any delay .

May, therefore, if approved, the statement of the financial year 2004-05, 2005-06, 2006-07, 2007-08 2008-09 and 2009-10 alongwith letters dated 02-05-2012 (flagged 'X') of Sri Chandra Shekhar, the then Additional Civil Judge (Sr. Div.), Varanasi now posted as Civil Judge (Sr. Div.) Kairana, Muzaffarnagar laid before Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Muzaffarnagar Judgship for his Lordship's kind perusal and orders?
