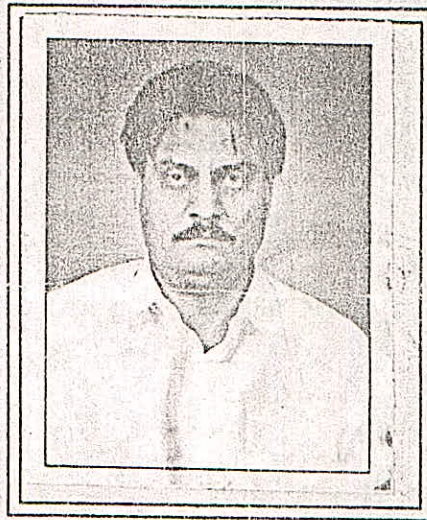

Note 1. Any breach or the conditions of the licence is punishable with imprisonment for a term which may extend to 3 months or with fine which may extend to Rs.500 or with both (section 10 of the Act.)

Note 2. Licence and warned that in case the sell or transfer any arms ammunition covered by the licence passed by them to any persons shall forth with inform in writing the district magistrate having jurisdiction or the officer incharge of the nearest police station of such sale or transfer together with the particulars of the arms and ammunition and the person to whom the have sold or transferred section 6th arms Act 1950 failure to give such information is punishable with imprisonment for a term which may extend to six months or with both (section 25(3) to the Act.)
