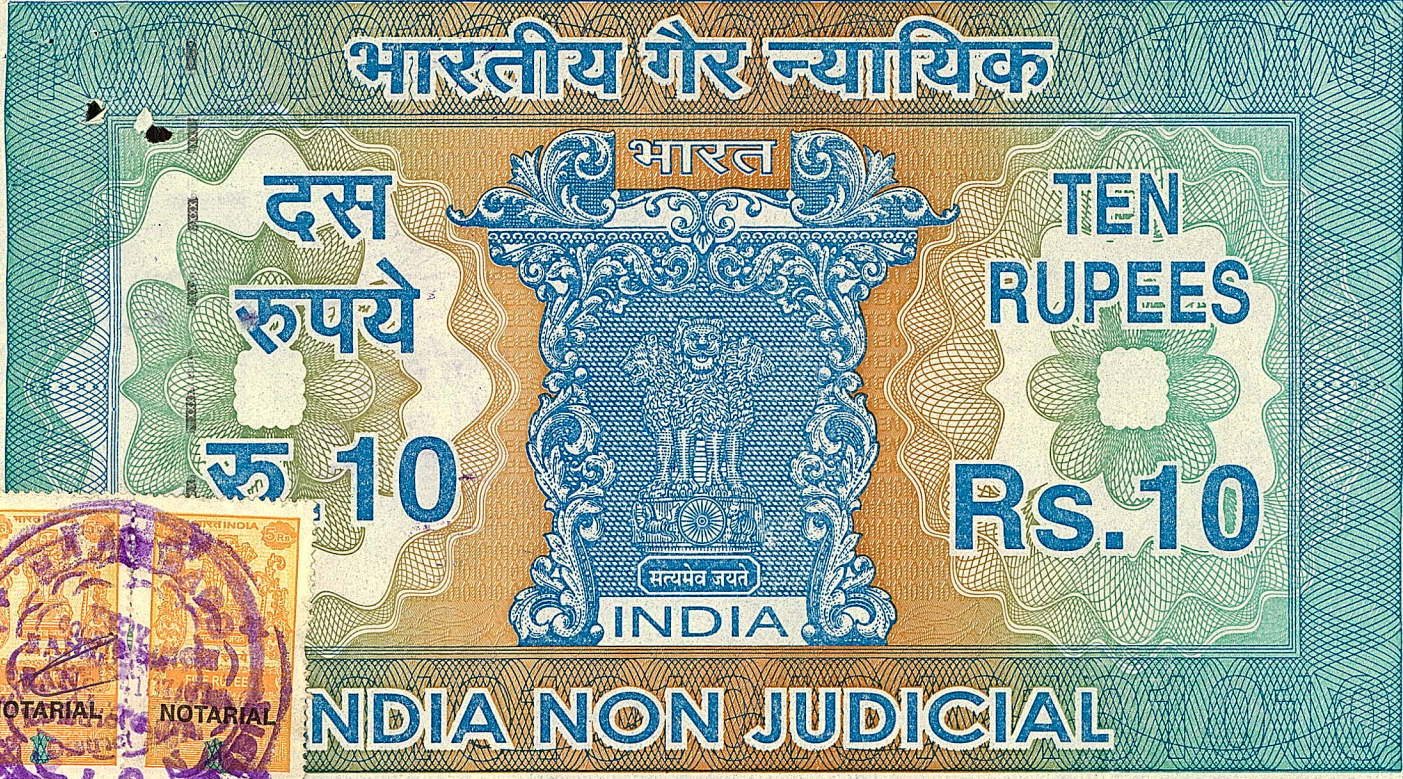

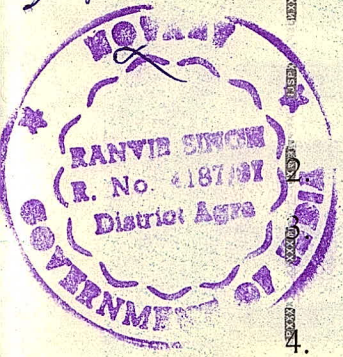

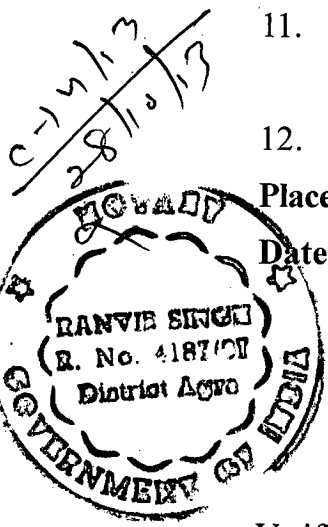

Sir,

With reference to your endt. no. 2955/I dated 10.09.2013 on the above subject, I have to say that Sri Ishtiaq Ali, Additional Chief Judicial Magistrate, Agra may kindly be asked to submit details of his dependent family members as on date and to **submit his declarations as per Section 6 (2) of the Passports Act, 1967, as well as following informations/ declarations, both on an 'Affidavit' :-**

- (c) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- (d) that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India;
