May kindly see the letters, placed below at flags 'A' & 'A-1', received from Sri Ishtiaq Ali, Additional Chief Judicial Magistrate, Agra regarding issuance of 'No Objection Certificate' for obtaining Passport.

In his letters, Sri Ishtiaq Ali has stated that he wants to go to Saudi Arabia for Haj/ Umra and for this he is need of Passport for himself and his family members. Thus, he requires 'No Objection Certificate' from the Hon'ble Court for obtaining Passport for himself. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Sri Hasan Ali (Father), Smt. Bano Begum (Mother) and Smt. Asmat Ishtiaq (Wife). He has, therefore, requested for issuance of 'No Objection Certificate' from Hon'ble Court for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Ishtiaq Ali. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Devendra Pratap Singh, Administrative Judge, Agra Judgship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Ishtiaq Ali, Additional Chief Judicial Magistrate, Agra, as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
