May kindly see the letter dated 19.2.2015 (at flag 'A') of Sri Ishtiaq Ahmad, Chief Judicial Magistrate, Pratapgarh by which he has submitted his movable and immovable property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2010-11, Sri Ali's income from Salary and other Sources is Rs.7,46,051/- from this amount, he has paid Rs.97,560/- against GPF, Rs.1440/- against GIS, Rs.53,928/- against Income Tax, Rs.48,342/- against Insurances, Rs.56,000/- towards Car loan repayment. The balance of his Saving Bank Account(s) enhanced for Rs.12,285/- this year. As such, total deductions /Savings/investment is Rs.2,69,555/-. Thus a sum of Rs.4,76,499/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2010-11.

(2) In the statement of movable and immovable property for the financial year 2011-12, Sri Ali's income from Salary and other Sources is Rs.17,03,682/- from this amount, he has paid Rs.2,09,692/- against GPF, Rs.3280/- against GIS, Rs.2,37,471/- against Income Tax, Rs.10,000/- against PPF, Rs.48,342/- against Insurances, Rs.67,200/- towards Car loan repayment. As such, total deductions /Savings/investment is Rs.5,75,985/-. The balance of his Saving Bank Account(s) decreased for Rs.53,718/- this year Thus a sum of Rs.11,81,414/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2011-12.

(3) In the statement of movable and immovable property for the financial year 2012-13, Sri Ali's income from Salary and other Sources is Rs.13,27,789/- from this amount, he has paid Rs.81,938/- against GPF, Rs.4800/- against GIS, Rs.1,07,290/- against Income Tax, Rs.10,000/- against PPF, Rs.48,342/- against Insurances, Rs.2,26,837/- towards Car and Home loans repayment. As such, total deductions /Savings/investment is Rs.2,52,370/-. The balance of his Saving Bank Account(s) decreased for Rs.7906/- this year. Thus a sum of Rs.10,83,325/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2012-13.

(4) In the statement of movable and immovable property for the financial year 2013-14, Sri Ali's income from Salary and other Sources is Rs.12,53,731/- from this amount, he has paid Rs.60,000/- against GPF, Rs.4800/- against GIS, Rs.1,12,617/- against Income Tax, Rs.30,000/- against PPF, Rs.26,744/- against Insurances, Rs.2,26,837/- towards Car and Housing loans repayment. The balance of his Saving Bank Account(s) enhanced for Rs.1,46,242/- this year. As such, total deductions /Savings/investment is Rs.6,07,240/-. Thus a sum of Rs.6,46,491/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2013-14.

The movable and immovable property statement for the financial years \_ \_ 2

2010-11, 2012-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 19.2.15 (flag 'A'). The Property statements for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13. The Property statements for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.15. As such there is delay in submitting the Property statement for the financial year 2010-11 and 2011-12 from the part of the officer for which officer has regretted.

In this connection, it is submitted that Sri Ali has already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice Abdul Mateen, the the Administrative Judge, Lucknow Judgeship on 19.9.2011 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Ishtiaq ~~Ali~~, Chief Judicial Magistrate, Pratapgarh may kindly be laid before Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders ?
