May kindly see the letters dated 26.5.18 and 30.11.2018 (flagged 'A' and 'A-1') by which Sri Istiaq Ahmad, Special Judge (E.C. Act)/Additional District and Sessions Judge, Rampur has submitted his property statements for the financial years 2014-15, 2015-16, 2016-17 & 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2014-15, Sri Istiaq Ahmad's total income from Salary and other Sources is Rs.12,93,780/- (Rs.12,43,780/- from Salary and Rs.50,000/- from Agriculture) from this amount Rs.75,279/- deducted against GPF, Rs.4800/- against GIS, Rs.93,788/- against Income Tax, Rs.4,28,388/- towards loans, Rs.45,000/- against PPF, Rs.26,744/- against LIC. As such, total deductions/ repayment/ Savings/investment is Rs.6,73,999/-. The balance of his Saving Bank Account(s) decreased for Rs.1,33,416/- this year against the balance of previous year. Thus a sum of Rs.7,53,197/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Istiaq Ahmad's total income from Salary and other Sources is Rs.14,83,521/- (Rs.14,33,521/- from Salary and Rs.50,000/- from Agriculture) from this amount Rs.1,03,311/- deducted against GPF, Rs.4800/- against GIS, Rs.1,33,298/- against Income Tax, Rs.4,28,388/- towards loans, Rs.25,000/- against PPF, Rs.26,744/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.44,740/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.7,66,281/-. Thus a sum of Rs.7,17,240/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2015-16.

(3) In the financial year 2016-17, Sri Istiaq Ahmad's total income from Salary and other Sources is Rs.15,78,552/- (Rs.15,28,552/- from Salary and Rs.50,000/- from Agriculture) from this amount Rs.1,90,465/- deducted against GPF, Rs.4800/- against GIS, Rs.1,48,523/- against Income Tax, Rs.4,28,388/- towards loans, Rs.40,000/- against PPF, Rs.26,744/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.1,18,718/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.9,57,638/-. Thus a sum of Rs.6,20,914/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2016-17.

(4) In the financial year 2017-18, Sri Istiaq Ahmad's total income from Salary and other Sources is Rs.15,89,818/- (Rs.15,39,818/- from Salary and Rs.50,000/- from Agriculture) from this amount Rs.2,40,346/- deducted against GPF, Rs.4800/- against GIS, Rs.1,68,529/- against Income Tax, Rs.4,28,388/- towards loans,

Rs.40,000/- against PPF, Rs.26,744/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.55,346/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.9,64,153/-. Thus a sum of Rs.6,25,665/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2017-18.

The property statement for the financial year 2014-15, 2015-16, 2016-17 and 2017-18 has been firstly submitted by the officer vide his letter dated 26.5.18 (flag 'A'). The movable and immovable property statement for the financial years 2014-15 and 2015-16 was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17, property statement for the financial years 2016-17 and 2017-18 was due to be submitted in the financial year 2018-19 i.e. on or before 31.3.19. As such there is delay in submitting the property statement for the financial year 2014-15 and 2015-16 from the part of the officer for which officer has regretted.

In this connection it is submitted that last time Sri Istiaq <sup>Ali</sup> ~~Ahmad~~ had submitted his property statement upto financial year 2013-14 which had been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Pratapgarh Judgeship which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 of Sri Istiaq <sup>Ali</sup> ~~Ahmad~~, Special Judge(E.C.Act)/Additional District and Sessions Judge, Rampur may kindly be laid before Hon'ble Mr. Justice Shashi Kant, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders ?
