May kindly see the letter, placed below at flag 'I', received from Sri Ram Dayal, Additional Chief Judicial Magistrate, Agra, by which he has submitted supplementary information/ details in connection with grant of permission to purchase immovable property i.e. 408.86 sq. meters of land, situated at Village- Mubarakpur Kotwa, Paragna & Tehsil- Sadar, District- Allahabad.

In this connection, it is submitted that the officer had applied through his letter dated 12.08.2011 (flag 'A') for grant of permission to purchase immovable property i.e. 408.86 sq. meters of land, situated at Village- Mubarakpur Kotwa, Paragna & Tehsil- Sadar, District- Allahabad from one Sri Virendra Nath Tiwari, S/o Late Prabhu Nath Tiwari, R/o Village- Mubarakpur Kotwa, Paragna & Tehsil- Sadar, District- Allahabad for Rs. 7,00,000/-, and accordingly the matter was submitted before Hon'ble Mr. Justice Imtiyaz Murtaza, vide a detailed office note dated 01.09.2011 (flagged 'II'), with the remark that the officer has not mentioned his gross salary & take home salary in Coloumn no. 3 of proforma of Court's C.L. no. 25/ Admin (A) dated 13.07.1998.

His Lordship Hon'ble Mr. Justice Imtiyaz Murtaza, then pleased to pass an order dated 06.09.2011 to ask for such details. The order was communicated vide Court's letter dated 07.09.2011 (flag 'III').

In reply of the Court's letter dated 07.09.2011, Sri Ram Dayal, vide his letter dated 13.09.2011 at flag 'I', has stated that his gross salary is Rs. 70,230/- and take home salary is Rs. 57,830/-. He has also furnished a copy of his pay slip (flag 'IV') in support of his submission.

It is further submitted that the officer has now furnished the required details with supporting papers as asked for therein the Court's order dated 06.09.2011 (flag 'II').

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Imtiyaz Murtaza for His Lordship's kind perusal & orders in the matter of grant of permission to the officer for purchase of immovable property i.e. 408.86 sq. meters of land, situated at Village- Mubarakpur Kotwa, Paragna & Tehsil- Sadar, District- Allahabad?
