In the letters, the officer has stated that his father-in-law Sri Shanker Singh Yadav is willing to give him a Maruti wagon-R car bearing registration No. UP93/ N-6327 as gift, for which he has written a consent letter also (Flagged 'B'). He ~~has~~ therefore, requested the Court to grant him permission to accept the car as gift from his father-in-law.

In this connection, it is submitted that in the consent letter (Flagged 'B'), the father-in-law of the officer has stated that his son-in-law (the officer) is his youngest son-in-law and considering his status and family need, he is willing to give the car as gift to him due to natural love and affection. It is further submitted that the relevant rules relating to gift [Rule 11 of the U.P. Government Servant's Conduct (Amendment) Rules, 1998] and relating to transfer of movabie property [Rule-24 (2) of U.P. Government Servant's conduct (Amendment) Rule-1998] runs as under: -

11. Gifts :- A government servant shall not without previous approval of Government :-

(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any member of his family who is dependent on him, to accept

Any gift, gratuity or reward from any person other than a close relative.

24(2) "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transection to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."
