May kindly see the letter dated 08-10-12, placed below at flag 'A', received from Sri Ram Kishore, Additional Chief Judicial Magistrate, Lakhimpur Kheri regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial year 2010-11 & 2011-12 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that from perusal of the aforesaid property statement it appears the in the financial year 2010-11 Sri Ram Kishore's total income (from salary and other resources) was Rs.11,33,742, from this amount his deductions was Rs. 3,59,414/-, Rs.1,23,936/- deposited in premium of LIC policies and deposited Rs.92,391/- (including interest) in various Bank Accounts, Rs 56,170/-. Total deductions and investment is Rs. 05,75,741/-. Thus a sum of Rs. 5,58,001/- was therefore available to him to meet out his family (four members) expenditure in whole financial year.

In this connection it is submitted that from perusal of the aforesaid property statement it appears the in the financial year 2011-12 Sri Ram Kishore's total income (from salary and other resources) was Rs.10,48,985, from this amount his deductions was Rs. 1,53,915/-, deposited Rs. 3,28,421/- in various Bank Accounts and, Rs.1,23,936/- deposited in premium of LIC policies. Total deductions and investment is Rs. 6,06,272/-. Thus a sum of Rs. 04,42,716,- was therefore available to him to meet out his family (four members) expenditure in whole financial year.

In this connection it is submitted that Sri Ram Kishore has already submitted his property statement up to financial years 2009-10 which has already been seen by Hon'ble Mr. Justice Rajeev Sharma, the then Administrative Judge, Ambedkarnagar on 05-01-2012 at flag 'Z'. The said property statement for the financial year 2009-10 is at flag 'M'.
