May kindly see the letter dated 5.5.2016 (at flag 'A') of Sri Ram Kishore-III, Additional Chief Judicial Magistrate, Mehrauni, Lalitpur by which he has submitted the reason for delay in connection with submission of property statements for the financial years 2012-13 and 2013-14.

Earlier Sri Ram Kishore has submitted his property statements for the financial years 2012-13 and 2013-14 vide his letter dated 24.11.2015(flag 'B') in which his salary was in decreasing order and also it was not clear whether it was his net salary or gross salary and also he has not given the cogent and concrete reason for not submitting the aforesaid statements in due time, hence a Court's letter dated 8.01.2016(flag 'C') has been sent to the officer in this regard. In reply of aforesaid Court's letter, officer has stated that because he was suspended from 21.3.13 to 15.1.14 and got only ~~subsistence~~ allowance in that period so his salary was in decreasing order but he has not given the cogent and concrete reason for not submitting the aforesaid statements in due time then Court's letters dated 22.2.16 and 16.4.16(flagged 'F' and 'G') has been sent to the officer in this regard.

In reply of aforesaid Court's letters, officer has submitted through his letter dated 5.5.16(flag 'A') that his mother was suffering from Cancer and he was busy in treatment of his ailing mother and during the treatment his mother was expired and after his death he was busy in taking care of his family members so these were the reasons for delay submission of aforesaid property statements, for which he has regretted and assured that in the future, he will submit the property statement for the financial years 2014-15 and 2015-16 in due time.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13, and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Sri Ram Kishore's total income from Salary is Rs.9,14,169/- from this amount Rs.1,20,000/- against GPF, Rs.4800/- against GIS, Rs.50,000/- against PPF, Rs.1,23,936/- against LIC and Rs.81,512/- against Income Tax. As such, total deductions /Savings/investment is Rs.3,80,248/-. The balance of his Saving Bank Account(s) decreased for Rs.88,355/- this financial year. Thus a sum of Rs.6,22,276/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Sri Ram Kishore's total income from Salary is Rs.4,18,979/- from this amount Rs.51,584/- against PPF, Rs.4000/- against GIS, Rs.1,03,943/- against LIC and Rs.10,400/- against Income Tax. As such, total deductions /Savings/investment is Rs.1,69,927/-. The balance of his Saving Bank Account(s) decreased for Rs.2,00,777/- this financial year. Thus a sum of Rs.4,49,829/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2013-14.

In this connection, it is submitted that Sri Ram Kishore has already submitted

his property statement upto the financial year 2011-12 which was seen by Hon'ble Mr. Justice Bachchoo Lal, the then Administrative Judge, Kheri on 17.9.13 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2012-13, and 2013-14 has been submitted by the officer vide his letter dated 24.11.15 (flag 'B'). The property statement for the financial years 2012-13, and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay

in submitting the aforesaid property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2012-13, and 2013-14 of Sri Ram Kishore-III, Additional Chief Judicial Magistrate, Mehrauni, Lalitpur may kindly be laid before Hon'ble Mr. Justice Sudhir Kumar Saxena, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
