May kindly see the letters dated 15.7.2016 and 13.12.2016 (at flag 'A' and 'A-1') of Sri Ram Kishore-III, Chief Judicial Magistrate, Maharajganj by which he has submitted the property statements for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2014-15, Sri Ram Kishore's Gross Salary is Rs.13,07,191/- from this amount Rs.1,20,000/- deducted against GPF, Rs.5600/- against GIS, Rs.75,000/- against PPF, Rs.94,015/- against LIC and Rs.1,53,961/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.6,51,424/- this financial year. As such, total deductions /Savings/investment is Rs.11,00,000/-. Thus a sum of Rs.2,07,191/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2014-15.

(2) In the statement of movable and immovable property for the financial year 2015-16, Sri Ram Kishore's Gross Salary is Rs.14,62,350/- from this amount Rs.2,19,180/- deducted against GPF, Rs.4800/- against GIS, Rs.50,000/- against PPF, Rs.93,984/- against LIC and Rs.1,63,223/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.6,20,189/- this financial year. As such, total deductions /Savings/investment is Rs.11,51,376/-. Thus a sum of Rs.3,10,974/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2015-16.

In this connection, it is submitted that Sri Ram Kishore has already submitted his property statement upto the financial year 2013-14 which was seen by Hon'ble Mr. Justice Sudhir Kumar Saxena, the then Administrative Judge, Lalitpur on 21.6.16 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer, ^{firstly} vide his letter dated 15.7.2016 (flag 'A'), which was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the aforesaid property statements from the
