WHEREAS you while posted as Chief Judicial Magistrate, Ambedkar Nagar,

- (i) took bribe to grant bail to Sri Avanish Rai, Sri Harbansh Rai and Sri Rahul Rai in Case Crime No. 53 of 2011 of P.S. Raje, Sultanpur
- (ii) while discharging your judicial and official duties, acted in a manner which might have created suspicion/ doubt about your honesty, integrity and fairness in the mind of others, which is a misconduct in itself.
- (iii) showed lack of administrative control over your office.
- (iv) claimed inflated quota for the period 01.01.2011 to 31.03.2011 and 01.01.2012 to 31.03.2012 whereby disobeyed the directions of the Hon'ble Court contained in clauses 10 and 11 of G.L. dated 19.05.2007.

WHEREAS on consideration of the enquiry report dated 22.02.2013 submitted by Sri Pratyush Kumar, Special Officer (Vigilance), High Court, Allahabad in V.B. Enquiry No. 07 of 2012 against you, the Hon'ble Court has decided to initiate disciplinary proceedings against you.

WHEREFORE, in exercise of powers conferred under Article 235 of the Constitution of India and all other powers enabling in this behalf, the Hon'ble Court has been pleased to place you under suspension as such with usual subsistence allowance with immediate effect.

During suspension period you shall be paid subsistence allowance under the provision of Fundamental Rule – 53 part II to IV of Financial Hand Book Volume-II at an amount equal to the leave salary which you would have drawn if you had been on leave on half average pay or on half pay and in addition, dearness allowance if admissible on the basis of such leave salary. But no dearness allowance shall be paid along with subsistence allowance if dearness allowance was not payable to you with the salary before suspension or if marginal adjustment in

respect of dearness allowance was not available. Any other compensatory allowance admissible from time to time shall be payable during the period of suspension on the basis of salary you were in receipt of on the date of suspension subject to satisfaction that you continue to meet the expenditure for which said compensatory allowances are admissible.

Payment towards the heads enumerated herein above shall be made only when you furnish a certificate to the effect that you are not engaged in any other employment, business, profession and vocation.
