In the matter of submission of information about purchase of a new Maruti Alto Lx car in the year 2006 by Sri Ram Kishor, presently posted as Civil Judge, Jr. Div., Khaga, Fatehpur, Hon'ble Mr. Justice M.I. Murtaza, vide his Lordship's order dated 19.03.2008 (flagged 'O'), quarried as to how the officer proposes to meet the household expenses within the seemingly exiguous carry home amount of Rs. 8725/- (after repaying car loan to the tune of Rs. 6000/- from his carry home salary of Rs. 14725/-) and as to whether the officer ^{Ras} ~~has~~ other means to fall back upon to supplement his income to live a life befitting to the status of a judicial officer. The order was communicated to the officer concerned vide Court's letter dated 16.04.2008.

Now, in reply of the Court's letter dated 16.04.2008, Sri Ram Kishor, vide his letter dated 30.07.2008 at flag 'X' has stated that: -

1. His family consists of himself and his wife only.
2. At the time of purchase of the car, his carry home salary was Rs. 14725/-, which enhanced to Rs. 21430/- at present.
3. As he has no liability of any other bank loan except of the car loan, he is able to maintain his family sufficiently and also able to maintain the status of a judicial officer.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra, Administrative Judge, Fatehpur Judgeship for His Lordship kind perusal and further orders in the matter as per direction contained in order dated 19.03.2008 of Hon'ble Mr. Justice M.I. Murtaza (flagged 'O')?
