May kindly see the application dated 14.10.2011 of Sri Anirudha Kumar Tiwari, Additional Chief Judicial Magistrate, Varanasi duly forwarded by District Judge, Varanasi regarding grant of personal pay under voluntary family planning programme, in terms of G.O. Pa. Ka. 4601/16-11-79-9/155/79, dated 23.02.1980 placed below at Flag 'A'.

According to papers received from Sri Anirudha Kumar Tiwari dated 14.10.2011 and papers available on his instant personal/ Misc. file details of the claim are as under:

- 1.His date of birth is 19.07.1966.
- 2.His present age is 45 years 3 months as per declaration.
- 3.He joined the U.P. Judicial service on 20.12.2003.
- 4.He has only one child declaration at Flag 'B'
- 5.The age of his child is 18 years and his date of birth is 10.08.1993 vide certificate issued by Additional Secretary and Officiating Chief Executive & Secretary, Indian Certificate of Secondary Education Examination 2008, and attested copy of certificate is at Flag 'D'
- 6.He has not got the personal Pay under voluntary family planning programme vide declaration at Flag 'C'
- 7.His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at flag 'B'
- 8.Neither any departmental enquiry is pending against Sri Anirudha Kumar Tiwari, Additional Chief Judicial Magistrate, Varanasi nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer (Confidential-A) section at flag 'E'

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79 dated 26.05.1980 and G.O. Pa.Ka. 2667/16-11-80-9/155/79 dated 11.06.1980 required declaration have been furnished by Sri Anirudha Kumar Tiwari and same are at Flag 'A'.

In this connection, it is submitted that Sri Anirudha Kumar Tiwari, Additional Chief Judicial Magistrate, Varanasi has completed 40 years of age on 19.07.2006 whereas his child completed 10 years of age on 10.08.2003 being his date of birth 10.08.1993. Therefore Sri Tiwari is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment with effect from 19.07.2006.
