
According to details as revealed from the file, the officer has taken bank loan to the extent of Rs. 3,85,000/--and the remaining cost has been met from the saving made by the officer.

The officer has put in seven years of service and his carry home salary is stated to be Rs. 13123/-. The amount of loan is shown to be repayable in 84 equal instalments of Rs. 6,100/-. The information furnished on the file is otherwise in accord with the U.P. Government Servant Conduct Rules. The other particulars have also been furnished in terms of Circulars issued by this Court.

The information meets with the requirement otherwise, as contained in the U.P. Government Servant Conduct Rules. Put up this information on the record.

In the present context, it is also desirable to ascertain how the officer proposes to meet the household expenses within the seemingly exiguous carry home amount of Rs.7,023/-. The question is whether the officer has other means to fall back upon to supplement his income.

The officer be called upon to furnish information. As soon as the information is received, the office would scrutinize and place the same before the Hon. A.J. concerned for appropriate orders.

Copy of Bank's certificate about loan is at Flag 'C'.


- 6- **Earlier purchase** : (1) Kelvinator Fridge Rs. 11,290/=
