May kindly see the letter dated 04.10.2013 of the District Judge, Aligarh forwarded therewith medical reimbursement claim of Sri Sunil Kumar-I, A.C.J.M., Aligarh, amounting to Rs.2,45,594.00, incurred in the treatment of Cardiac Attack at Fortis Escorts Heart Institute, New Delhi for the period from 13.05.2013 to 22.05.2013 placed at Flag 'A'.

Through the said letter the District Judge has forwarded the original claim papers and stated that Sri Sunil Kumar-I, A.C.J.M., Aligarh has submitted the medical reimbursement claim for Rs.4,18,180.00 and after the technical examination the C.M.O. Aligarh has verified the claim for Rs.2,45,594.00. The District Judge, Aligarh has requested this Court to forward the claim to the Government.

It is pertinent to mention here that Sri Sunil Kumar-I, A.C.J.M., Aligarh has submitted another claim amounting to Rs.5,09,156.00, incurred in the treatment of Cardiac Attack at Fortis Escorts Heart Institute, New Delhi for the period from 09.05.2013 to 12.05.2013 as the claim is more than Rs.2,50,000.00 as such the said claim has been forwarded to the Government, with the approval of Learned Registrar General, through Court's letter dated 21.11.2013 placed at Flag 'B'.




