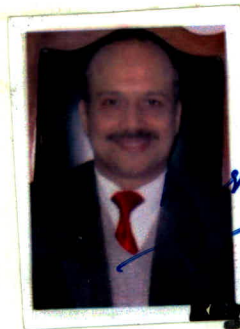


IDENTITY CERTIFICATE

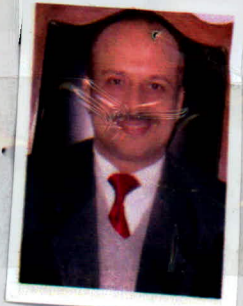

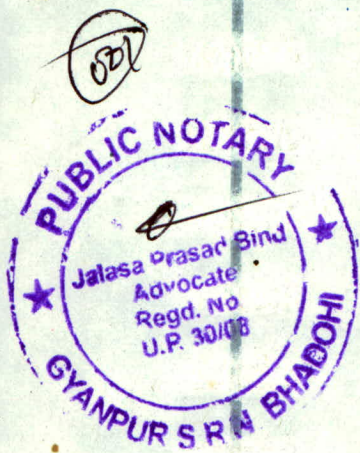

years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect their of to imprisonment for not less than two years.

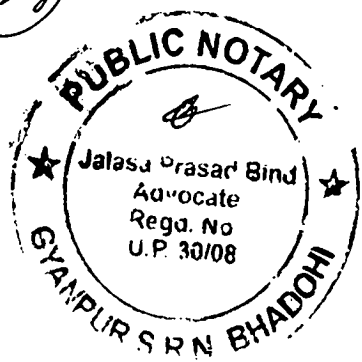
- (f) That the proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India.
