May kindly see the letters, placed below flag at 'A' received from Sri Mridul Kumar Mishra, Additional District & Sessions Judge, Bhadohi at Gyanpur for issuance of 'Identity Certificate' for obtaining Passport.

In his letter, Sri Mishra has stated that he wants to apply for issuance of passport and for the purpose is willing to obtain 'Identity Certificate' from the Hon'ble High Court. He has also furnished four passport size photographs of himself and required details and declarations on an 'Affidavit' as per G.O. and Section 6 (2) of Passport Rules, which may kindly be seen at flag 'B'. His dependent family members are Smt. Monu Tripathi (Wife) and Km. Srishty Mishra (Daughter). He has, therefore, requested to place his application before Hon'ble Court for issuance of 'No Objection/ Identity Certificate' in his favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). Here it is also to submit that as per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Mridul Kumar Mishra. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Bhadohi at Gyanpur and if His Lordship approves, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Mridul Kumar Mishra, Additional District & Sessions Judge, Bhadohi at Gyanpur, as requested, for obtaining Passport with the direction of the Court that he should take prior permission of the Court before proceeding abroad?
