Discuss-

Whether any copy of book sought to be published has been given and consent of officer has been obtained in the light of G.O.

In this connection it is submitted that no copy of book sought to be published has been given. It was also queried earlier by the then Registrar (Budget) on the earlier office note dated 15.09.2011 (flag 'YY') as to whether a copy of the book can be asked from the officer. In reply of the said query, it was already reported in para 2 of the office note dated 18.10.2011 (flag '2X') that it appears to be not very proper to ask for a copy of the book/ manuscript written by the officer, as such type of book/ manuscript seems to be a private and valuable thing of the writer which used to be saved for getting circulated before its publication through a proper medium, and it may be possible that the officer hesitate to do so also in this case. In the similar case of Sri T.B. Singh, A.D.J. also, he had avoided such type of situation by saying that the book/ manuscript are huge in size.

In the light of G.O., consent of the officer has already been asked through earlier Court's letter dated 11.10.2010 (flag 'C') and it had been furnished by the officer through his letter dated 27.10.2010 (flag 'A-1').
