May kindly see the letters, placed below at flag 'A', & 'A-I' received from Sri Mridul Kumar Misra, Additional District Judge, Jaunpur regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Mridul Kumar Misra had submitted his movable & immovable property statements for the financial years 2012-13 & 2013-14 through his letter dated 05-01-2016 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letter dated 12-02-2016 (flagged 'C').

Now, Sri Mridul Kumar Misra has submitted required informations alongwith required through his letter dated 19-02-2016 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13 & 2013-14, the income from salary and arrears is Rs.23,37,286/- and from this amount, Rs.2,74,880/- is deducted against GPF, Rs.9600/- against GIS, Rs.2,28,679/- against Income Tax, Rs.4,400/- against LIC, Rs.1,22,400/- against Vehicle loan, Rs.6,10,000/- against FDR. As such, total deductions/ repayment is Rs.12,49,959/-. The balance of his savings bank account (s) reduced for Rs.8,672/- this year. Thus, a sum of Rs.10,95,999/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2012-13 & 2013-14.

In this connection it is submitted that Sri Mridul Kumar Misra has already submitted his property statement of the financial year 2011-12 (statement is at flag 'M') which had already been seen on 13-02-2015 by Hon'ble Mr. Justice A. K. Singh, ~~Additional~~ Administrative Judge, Varanasi Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in

its next financial year i. e. in 2014-15 up to March 2015. He has submitted the movable and immovable property statement for the financial year 2012-13 & 2013-14 vide his letter dated 05-01-2016, as such, there is delay in submitting the same statements for the years 2012-13 & 2013-14. He has <sup>stated that he has</sup> submitted the property statements belatedly as earlier correspondence regarding property statements up to the financial year 2011-12 was in continuation till 14-08-2014 and therefore he submitted the instant property statements thereafter. However, the reasons as stated above by the officer, is not appears to be acceptable as the property statement for the financial year 2013-14 was due in the financial year 2014-15 and he has submitted he same through his letter dated 05-02-2016, even after about one year after the due date and after last correspondence on 14-08-2014 regarding property statements up to the financial 2011-12.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letters dated 05-01-2016 & 19-02-2016 (flagged 'A' & 'A-I' ) of Sri Mridul Kumar Misra, Additional District Judge, Jaunpur be laid before Hon'ble Mr. Justice Ashwani Kumar Singh, Administrative Judge, Jaunpur Judgeship for his Lordship's kind perusal and orders?
