In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

In the financial years 2014-15 and 2015-16, Sri Mishra total income from salary is Rs.25,17,286/- (Rs.23,37,286/- from Salary and Rs.1,80,000/- from Bank interest) and from this amount he has paid Rs.1,94,876/- against GPF, Rs.9600/- against GIS, Rs.2,28,679/- against Income Tax, Rs.122400/repayment of loan, Rs.5,52,200/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.14,003/- in this year. As such, total deductions /Savings/ investment are Rs.11,21,758/-. Thus a sum of Rs.13,95,528/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2014-15 and 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 3.5.18 (flag 'A') which was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17. As such there is delay in submitting the aforesaid Property statements from the part of officer for which he has stated that delay be condone.

In this connection, it is submitted that Sri Mishra had already submitted his property statement upto 2013-14 which was seen by Hon'ble Mr. Justice Ashwani Kumar Singh, Administrative Judge, Jaunpur Judgeship on 30.3.2016 at flag 'Z' and the statement at flag 'M'.
