May kindly see the letter dated 30.10.2013 (at Flag 'A') of Sri Mridul Kumar Mishra, Additional Civil Judge (Sr. Div.), Jaunpur duly forwarded by the District Judge, Jaunpur regarding inclusion of LL.M. in his service records, to this Court.

In his aforesaid letter, Sri Mridul Kumar Mishra, Additional Civil Judge (Sr. Div.), Jaunpur has sent attested copy of LL.M. marksheets & its degree (at Flags 'B', 'C' & 'D' respectively) and stated therein that due to human error and by mistake, he has not mentioned LL.M. degree in his U.P. Nyayik Sewa Form whereas it is possibility to enclose LL.M. marksheets and its degree with U.P. Nyayik Sewa form. He has requested the Court to include degree of LL.M. in his service record.

In this connection it may be submitted that Sri Mridul Kumar Mishra has joined U.P. Nyayik Sewa on 22.12.2003 and completed LL.M. degree before joining of U.P. Nyayik Sewa. He has not mentioned LLM in the U.P. Nyayik Sewa form 2000 but enclosed LL.M. final year marksheet and its provisional certificate (at Flags 'E' & 'F' respectively). Generally inclusion of any degree in the service record of any Judicial Officer on the basis, either the officer has not completed educational course before coming into service and take permission for completion by this Court, or if mention in the Application form of UP. Nyayik Sewa/ U.P.H.J.S. about pursuing and completed before joining the service, but in this matter officer has completed LL.M. before Filling the application form of U.P. Nyayik Sewa.

In this connection, it is further submitted that Appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included in the service records of Sri Mridul Kumar Mishra with the permission of Government of U.P. as the appointing authority of Judicial Officers is Government of U.P. Therefore, it seems proper the application of Sri Mridul Kumar Mishra, Additional Civil Judge (Sr. Div.), Jaunpur regarding inclusion of qualification of LL.M. degree in his service records may be sent to the Government for obtaining orders.

If approved by Learned Registrar (Budget), the file may kindly be laid before Hon'ble Mr. Justice Surendra Singh, Administrative Judge, Jaunpur for kind

perusal and order to the effect that if His Lordships satisfied with the reason given by the Officer that due to human error and by mistake, he has not mentioned LL.M. degree in his U.P. Nyayik Sewa Form, then copy of letter dated 30.10.2013 of Sri Mridul Kumar Mishra, Additional Civil Judge (Sr. Div.), Jaunpur regarding inclusion of qualification of LL.M. degree in his service records, attested copy of final degree of LL.M., attested copies of marksheets of LL.M. and attested copy of form of U.P. Nyayik Sewa of Sri Mridul Kumar Mishra may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. for obtaining necessary orders of the Government in the matter.
