May kindly see the letter dated 14.10.2014 (flag 'A') placed below received from Sri Ravindra Kumar Srivastava, Special Chief Judicial Magistrate, Varanasi by which he has submitted his salary and deduction, income tax deductions, LIC Premium etc. from financial years 2008-09 to 2013-14 and property statement for the financial year 2013-14.

Earlier Sri Srivastava has submitted his property statements for the financial years 2009-10 and 2010-11 vide his letter dated 2.11.11(flag 'B') then a Court's letter dated 29.11.11(flag 'C') has been sent to the officer to send his property statement for the financial year 2008-09 also as the payment of Income tax was not mentioned in the earlier sent property statement for the financial year 2008-09. In the meantime officer has submitted his property statements for the financial years 2011-12 and 2012-13 vide his letter dated 18.7.2013(flag 'D'). Again a Court's letter dated 20.8.13(flag 'E') has sent to the officer to sent his property statement for the financial year 2008-09. In reply officer has submitted his property statement for the financial year 2008-09 vide his letter dated 4.9.13(flag 'F'). Then a Court's letter dated 18.12.13(flag 'G') has been sent to the officer to furnish the annual income and details of deductions in the column no. 8 of the movable property statements. But he has furnish his Photocopy of the property statements for the financial year 2011-12 and 2013-13 with details of deductions vide his letter dated 24.5.2014(flag 'H') but he has not submitted his details of deductions of his property statements from 2008-09 to 2013-14 and property statement for the financial year 2013-14. Hence a Court's letter dated 26.8.2014(flag 'K') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer has submitted his details of deductions for the financial years from 2008-09 to 2013-14 and property statement for the financial year 2013-14 vide his letter dated 14.10.2014(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for financial years 2008-09, 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings/investment and expenditure made by him are as under, prepared in chart.
