Sapna Tripathi, Judicial Magistrate, Fatehpur has submitted her property statement for at the time of entering into Judicial Service and for the the financial years 2013-14 and 2014-15 but as per property statement for the financial year 2013-14 of Smt. Tripathi, it appears that he got Rs.4,92,954/- as gross salary and from this amount Rs.1800 deposited against GIS, Rs.35,092/- against LIC, Rs.65,000/- against PPF, Rs.14,700/- against Income Tax and the balance of his Saving bank account enhanced to Rs.3,59,739/- against her previous year balance. Thus a sum of Rs.16,623/- was therefore available to her to meet out her family consisting of two members for whole year.

I am therefore, to request you kindly to ask Smt. Tripathi to submit her clarification, as to how she managed his family that year with a meager amount of Rs.16,623/-, to this Court, at an early date, so that necessary action may be taken in the matter.


