May kindly see the letter dated 2.5.2016 at flag 'A' of Smt. Sapna Tripathi, Judicial Magistrate, Fatehpur by which she has submitted her clarification regarding Property statement for the financial year 2013-14 in connection with submission of property statements for the financial years 2013-14 and 2014-15.

Earlier officer has submitted her property statement of at the time of entering into Judicial Service vide her letter dated 16.9.15(flag 'B') but she has not submitted her property statements for the financial years 2013-14 and 2014-15, hence a Court's letter dated 5.12.2015(flag 'C') has been sent to the officer in this regard. In reply of aforesaid Court's letter, officer has submitted the property statements for the financial years 2013-14 and 2014-15 vide her letter dated 16.12.2015('D') but in which she has not mentioned her details of deductions of Salary and property filled immovable property statements for the aforesaid periods. Then a Court letter dated 3.2.16(flag 'E') has been sent to the officer to send her property statements for the aforesaid periods after mentioning the details of deduction of her salary and property filled immovable property statements for of her joining and the aforesaid periods. In reply of aforesaid Court's letter, officer has submitted her property statements for at the time of joining and for the financial years 2013-14 and 2014-15 vide her letter dated 25.2.2016(flag 'F') and after calculations it has been found that after deductions/investment/saving it has been found that a sum of Rs.16,623/- was left to her to meet out her family of two members in the financial years 2013-14, then a Court's letter dated 13.4.16(flag 'G') has been sent to the officer.

In reply of aforesaid Court's letter, officer has submitted her reply of aforesaid Court's letter vide her letter dated 2.5.16(flag 'A') in which she has stated that ~~his~~ husband Sri Kshitish Pandey was posted from 21.5.13 to 22.9.14 as Additional Civil Judge(Jr.Div.), Fatehpur and he got his Salary as Rs.5,15,624.- (in the financial year 2013-14) and Rs.4,60,670.- (in the financial year 2014-15) and with mutual understanding they bears the expenses of the family.

In this connection, it is submitted that as per statement of movable and immovable property of at the time of entering into U.P.Judicial Service and for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(i) SB A/c No....39118 balance at the time of joining Nil.

Gift by father:- Maruti Dzire Car.

- (2) 2 Set of gold Neckless: 2 lakh.
- (3) 2 Set bangles worth Rs. 2 Lakh.
- (4) 25 Ring 1 Lakh.
- (5) 5 Earrings RS.30,000/-.
- (6) 2 Gold Chain Rs.50,000/-.
- (7) Silver - Rs.50,000/-.

(ii) In the statement of movable and immovable property for the financial year 2013-14, Smt. Tripathi annual income from salary is Rs.4,92,954/- and from this amount Rs.1800/- deducted against GIS, Rs.35,092/- against LIC, Rs.65,000/- against PPF, Rs.14,700/- against Income Tax. The balance of her Saving bank account(s) enhanced for Rs.3,59,739/- this financial year. As such, total deductions/Saving/investment is Rs.4,76,331/- . Thus a sum of Rs.16,623/- was therefore available with her to meet out her household expenditure of her family consisting of two members in financial years 2013-14.

(iii) In the statement of movable and immovable property for the financial year 2014-15, Smt. Tripathi annual income from salary is Rs.7,21,252/- and from this amount Rs.1,08,474/- against CPF, Rs.2400/- deducted against GIS, Rs.1,14,690/- against LIC, Rs.75,000/- against PPF, Rs.33,630/- against Income Tax. The balance of her Saving bank account(s) enhanced for Rs.2,21,215/- this financial year. As such, total deductions/Saving/investment is Rs.555409/- . Thus a sum of Rs.1,65,843/- was therefore available with her to meet out her household expenditure of her family consisting of three members in financial years 2014-15.

It is pertinent to mention here that the husband of the officer Sri kshitij Pandey is Addl. Civil Judge(Jr.Div.), Fatehpur whose income was Rs.5,15,624/- (in the financial year 2013-14) and Rs. 4,60,670/- (in the financial year 2014-15).

The officer has submitted his property statement of at the time of entering into Judicial Service vide her letter dated 16.9.2015(flag 'B') which was due to be submitted at the time of her joining the U.P. Judicial Service and for the financial years 2013-14 and 2014-15 vide her letter dated 16.12.2015('D'). As such there is delay in submitting the property statement of at the time of her joining the U.P. Judicial Service from the part of officer for which officer has submitted that delay caused due to her marriage, training in JTRI, Lucknow and taking of maternity leave and child care leave for which she has regretted.

May, if approved, the statements of movable and immovable property of at the time of entering into U.P. Judicial Service and for the financial years 2013-14 and 2014-15 of Smt. Sapna Tripathi, Judicial Magistrate, Fatehpur may kindly be laid before Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Fatehpur Judgeship for His Lordship's kind perusal and orders?
