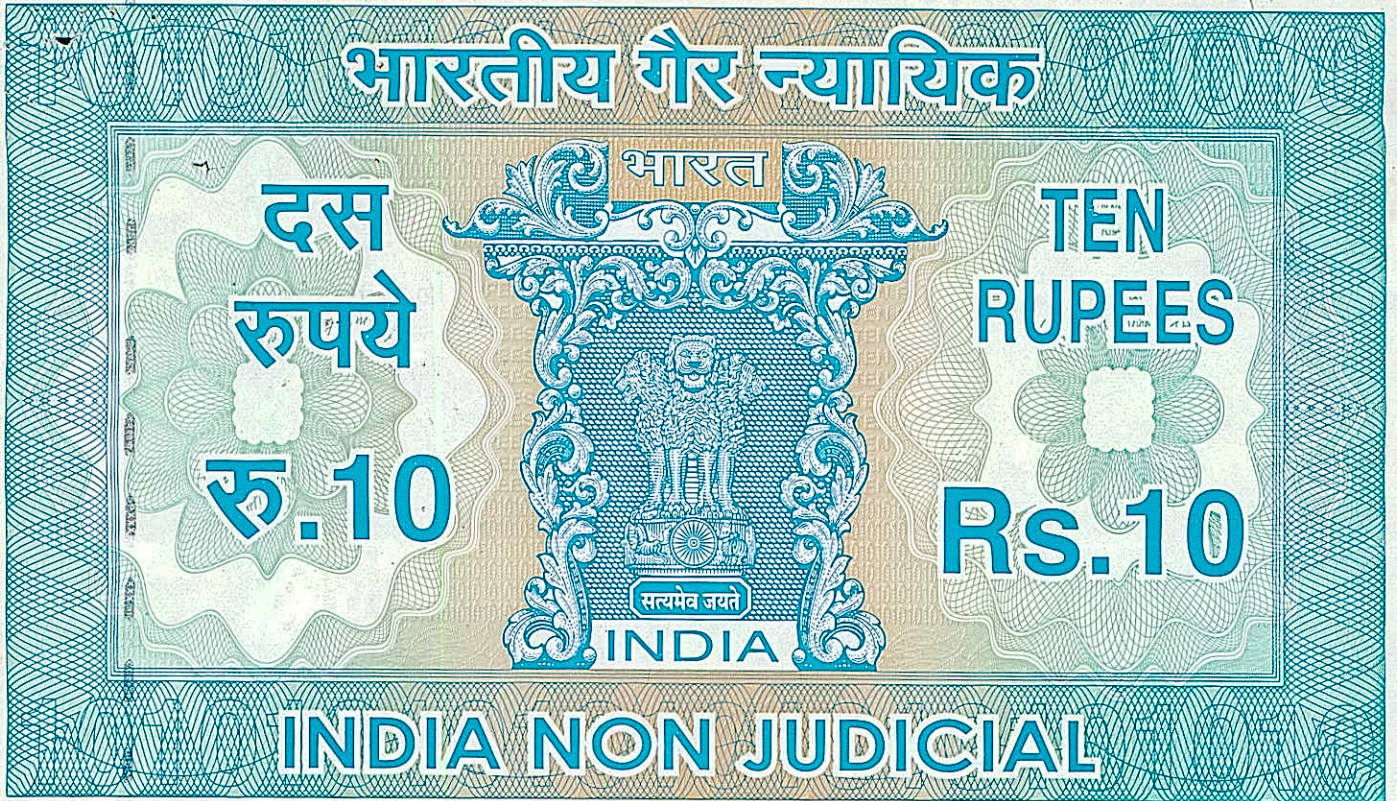

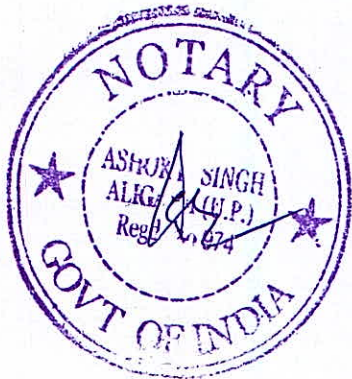

With reference to endt. no. 2070/ XV- Civil dated 26.06.2013 on the above subject, I have to say that Smt. Poonam Rajput, Additional Chief Judicial Magistrate, Aligarh may kindly be asked to intimate her dependent family members with relation as on date and to **submit her declarations as per Section 6 (2) of the Passports Act, 1967, as well as following informations/ declarations, both on an 'Affidavit' :-**

- (a) that the applicant is a citizen of India;
- (b) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- (d) that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
