May Kindly see the letter, placed below at flag 'A', received from Smt. Poonam Rajput, Civil Judge (Jr. Div.), Saharanpur regarding grant of permission to appear in LL.M. 1st year examination (session 2007-08) via correspondence from Kurukshetra University, Kurukshetra, Haryana.

In her letter, Smt. Poonam Rajput has stated that she has taken admission in two year's LL.M. course via correspondence from Kurukshetra University, Kurukshetra, Haryana in the year 2007 (Session 2007-08). The proposed date for the 1st year examination is May-June 2008. She has also submitted copy of admission card, which is at flag 'B'. She has, therefore, requested that he may kindly be permitted to appear in the above mentioned 1st year LL.M. examination (Session 2007-08).

In this connection, it is submitted that a judicial officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No. 24/1066-Appointment (B) dated 21.08.1967 (copy at flag X), subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours. The Head of the Department should verify from the educational institutions concerned the hours during which classes will be held and permission should be given only in cases where these hours are clearly beyond the prescribed office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his/her normal work or that public work suffers, in any way.

In the instant case, it is to mention that the officer has joined the judicial service on 30.01.2004. As the course, which she wants to do is through correspondence, there seems to be nothing objectionable, if she will be granted the permission, as requested, subject to the conditions mentioned above. At present, she may be permitted to appear in 1st year examination (Session 2007-08) of the course only, as requested. However, acceptance of her request is on the discretion of the Court.

May Kindly see the letter, placed below at flag 'Z', received from Smt. Poonam Rajput, Civil Judge (Senior Division), Pratapgarh regarding grant of permission to appear in 2nd year examination of LL.M. of Kurukshetra University, Kurukshetra, Haryana, scheduled to be held in May 2010.

Smt. Poonam Rajput in her letter has stated that she has passed LL.M. 1st year from Kurukshetra University, Kurukshetra, Haryana via correspondence with the permission of the Hon'ble High Court in the year 2008 and she has taken admission in LL.M. 2nd year. The proposed date for the examination is May 2010. She has also submitted a copy of the admission card and has requested that she may kindly be allowed to appear in the above mentioned 2nd year examination (Session 2009-2010).

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 30.01.2004. Earlier, vide Court's order dated 06.02.2008 (flag 'B'), she was allowed to appear in LL.M. 1st year examination (correspondence course) from Kurukshetra University, Kurukshetra, Haryana.
