May kindly see the letter, placed below at **flags 'A' & 'B'** received from Smt. Poonam Rajpoot, Additional District & Sessions Judge/ F.T.C., Muzaffarnagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial year 2014-15, income from salary is Rs.11,66,309/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.73,431/- against GPF, Rs.1,22,325/- against Income Tax, Rs.9,349/- against premium of LIC policies, Rs.75,000/- against Car loan, Rs.2,94,924/- against Personal loans and Rs.1,000/- deposited in her PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.5,80,829/-. The balance of her savings bank account(s) reduced for Rs.12,720/- this financial year from previous year's balance. Thus, a sum of Rs.5,98,200/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

(2) In the financial year 2015-16, income from salary is Rs.15,23,312/- and from this amount, Rs.5,600/- is deducted against GIS, Rs.81,617/- against GPF, Rs.2,28,500/- against Income Tax, Rs.11,842/- against premium of LIC policies, Rs.2,94,924/- against Personal loans and Rs.1,000/- deposited in her PPF account. The balance of her savings bank account(s) enhanced for Rs.64,032/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.6,87,515/-. Thus, a sum of Rs.8,35,797/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

In this connection it is submitted that Smt. Poonam Rajpoot has already submitted her property statement upto the financial year 2013-14 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Ran Vijai Singh, the then Administrative Judge, Muzaffanagar at **flag 'Z'**. At that time, the officer has also submitted property statement for the financial year 2014-15, but as per two year's block policy, the same is being considered now with the statement of property statement for the financial

year 2015-16. The statement of the financial year 2016-17 will be taken up for consideration alongwith the statement of 2017-18, which will be submitted by the officer in near future.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., in 2016-17 upto March 2017. She has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 vide her letters dated 28.09.2015 & 04.01.2018 (at flags 'B' & 'A' respectively). As such, there is delay in submitting the property statements for the financial years 2015-16 from the part of the officer.

May, therefore, if approved, the property statements for the financial years 2014-15 and 2015-16 alongwith letters dated 04.01.2018 & 28.09.2015 (at flags 'A' & 'B' respectively) of Smt. Poonam Rajpoot, Additional District & Sessions Judge/ F.T.C., Muzaffarnagar be laid before Hon'ble Mr. Justice Abhinava Upadhya, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
