① The office note dated 23.01.2017 (at Flag 'X') in the matter of inclusion of qualification of LL.M. in the service records of Smt. Poonam Rajput, Addl. District & Sessions Judge/F.T.C., Muzaffar Nagar was submitted before Hon'ble Mr. Justice Ran Vijai Singh, the then Administrative Judge, Muzaffar Nagar Judgeship. The said office note is received back without any order due to change of Hon'ble Administrative Judge of Muzaffarnagar Judgeship.

In aforesaid office note it is mentioned that Smt. Poonam Rajput, Addl. District & Sessions Judge/FTC, Muzaffar Nagar has sent a letter dated 27.07.2016(flagged at A1) duly forwarded by the District Judge, Muzaffar Nagar for inclusion of degree of LL.M. in her service records.

It may be recalled earlier through her letter dated 15.12.2014(Flags at 'A'), Smt. Poonam Rajput, the then Addl Chief Judicial Magistrate, Aligarh had submitted attested copies of final year marksheets and provisional certificate of LL.M. for aforementioned purpose. Thereafter, vide this Court's letter dated 23.02.2015 (Flag at 'B') she was informed to submit attested copy of degree of LL.M in place of provisional certificate of LL.M. In reply to which Smt. Poonam Rajput has sent instant letter dated 27.07.2016 through which she has submitted attested copies of marksheets as well as degree of LL.M.(Flag at 'C', 'C1' & 'D') and requested for inclusion of qualification of LL.M. in her service record.

In this connection it may be submitted that Smt. Poonam Rajput joined the U.P. Nyayik Sewa on 30.01.2004. She has completed qualification of LL.M. through distance learning mode from Kurukshetra University, Kurukshetra after joining the service with the permission of Hon'ble High Court vide Court's letter No. 4085/IV-3065/Admin. (A)/dated 11.03.2010 (at Flag 'E').

It is further submitted that appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included in the service records of Smt. Poonam Rajput, Addl. District & Sessions Judge/F.T.C., Muzaffar Nagar with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid application of Smt. Poonam Rajput, regarding inclusion of LL.M. Degree in her service records may be sent to Government of U.P. for obtaining necessary orders.
