May kindly see the letter dated 22.7.13 at flag 'A' of Smt. Anjana, Additional Chief Judicial Magistrate, Chandausi, Moradabad has submitted her Statement of movable and immovable property for the financial years 2010-11, 2011-12 and 2012-13.

As per Court's Circular letter dated 13.5.2004, property statement for the financial years 2012-13 and 2013-14 will be due in the financial year 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11 and 2011-12 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2010-11 Smt. Anjana's Gross Salary is Rs.11,19,064/- from this amount Rs.2,03,998/- against GPF, Rs.1440/- against GIS, Rs.66,528/- towards Car loan Installments, Rs.50,000/- against PPF, Rs.19,400/- against LIC . The balance of his Saving Bank Account(s) enhanced for Rs.€ 200/-(approx.) this year. As such, total deductions /repayment/Savings/investment is Rs.3,47,566/-. Thus a sum of Rs.7,71,498/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2010-11.

(2) In the financial year 2011-12, Smt. Anjana Gross salary is Rs.10,17,696/- from this amount Rs.1,09,697/- against GPF, Rs.4800/- against GIS, Rs.66,523/- towards Car loan Installments, Rs.19,400/- against LIC . The balance of his Saving Bank Account(s) enhanced for Rs.3,500/-(approx.) this year. As such, total deductions/repayment/ Savings/ investment is Rs.2,03,925/-. Thus a sum of Rs.8,13,771/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2011-12

The movable and immovable property statement for the financial years 2010-11 and 2011-12 has been submitted by the officer vide her letter dated 22.7.13 (flagged 'A') which was due to be submitted in third financial year on or before 31.3.13 . As such there is some delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted last time Smt. Anjana had already submitted his property statement upto financial year 2009-10 which had
