May kindly see the letters dated 22.7.2013, 17.1.2018 and 18.4.2018 at flag 'A', 'A-1' and 'A-2' of Smt. Anjana, Additional District and Sessions Judge, Etawah by which she has submitted her Statement of movable and immovable property for the financial years 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17.

As per Court's Circular letter dated 13.5.2004, property statement for the financial years 2012-13 alongwith property statement for the financial year 2013-14 was to be due in the financial year 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below.

(1) In the financial year 2012-13, Smt. Anjana Gross Salary is Rs.10,76,068/- from this amount Rs.84,000/- against GPF, Rs.4800/- against GIS, Rs.81,018/- against Income Tax, Rs.10,000/- against PPF, Rs.8380/- against LIC. As such, total deductions /repayment/Savings/investment is Rs.1,88,198/-. The balance of his Saving Bank Account(s) decreased for Rs.3714/-(approx.) this year against the balance of previous year. Thus a sum of Rs.8,91,584/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2012-13.

(2) In the financial year 2013-14, Smt. Anjana Gross Salary is Rs.11,52,099/- from this amount Rs.1,26,226/- against GPF, Rs.4400/- against GIS, Rs.1,29,406/- against Income Tax, Rs.100,000/- against PPF, Rs.8380/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.35,878/-(approx.) this year against the balance of previous year. As such, total deductions /repayment/Savings/investment is Rs.4,04,290/-. Thus a sum of Rs.7,47,809/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2013-14.

(3) In the financial year 2014-15, Smt. Anjana Gross Salary is Rs.11,62,014/- from this amount Rs.1,04,301/- against GPF, Rs.4800/- against GIS, Rs.1,22,573/- against Income Tax, Rs.1,50,000/- against PPF, Rs.8380/- against LIC. As such, total deductions /repayment/Savings/investment is Rs.3,90,054/-. The

balance of his Saving Bank Account(s) decreased for Rs.37,011/- (approx.) this year against the balance of previous year. Thus a sum of Rs.8,08,971/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2014-15.

- (4) In the financial year 2015-16, Smt. Anjana Gross Salary is Rs.11,39,691/- from this amount Rs.60,131/- against GPF, Rs.3600/- against GIS, Rs.1,31,124/- against Income Tax, Rs.150,000/- against PPF, Rs.8380/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.5,40,738/-(approx.) this year against the balance of previous year. As such, total deductions /repayment/Savings/investment is Rs.8,93,973/-. Thus a sum of Rs.2,45,718/- was therefore available with her to meet out the household expenditure of her family consisting of four member in the financial year 2015-16.

And as per two years block policy, the property statement for the financial year 2016-17 will be taken up for consideration alongwith property statement for the financial year 2017-18, which will be submitted by the officer in near future, be due in the financial year 2018-19.

The movable and immovable property statement for the financial years 2012-13 has been submitted by the officer vide her letter dated 22.7.2013(flag 'A') and movable and immovable property statement for the financial years 2013-14, 2014-15 and 2015-16 has been submitted by the officer vide her letter dated 17.1.2018 (flagged 'A-1'). The property statement for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 and property statement for the financial year 2014-15 and 2015-16 was due to be submitted in the financial year 2016-17. As such there is delay in submitting the Property statement for the financial years 2013-14, 2014-15 and 2015-16 from the part of officer.

It is pertinent to mention that the husband of the officer Sri Anil Kumar is a Advocate whose annual income are Rs.2,71,640, Rs.4,00,000/-, Rs.4,25,000/- and Rs.4,50,000/- in respective financial years.

In this connection it is submitted last time Smt. Anjana had already submitted her property statement upto financial year 2011-12 which had already been seen by Hon'ble Mr. Justice Krishna Murari, the then Administrative Judge, Moradabad Judgeship on 19.12.13 which is at flag 'Z' . . . 3

and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 of Smt. Anjana, Additional District and Sessions Judge, Etawah may kindly be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Etawah Judgeship for His Lordship's kind perusal and orders ?
