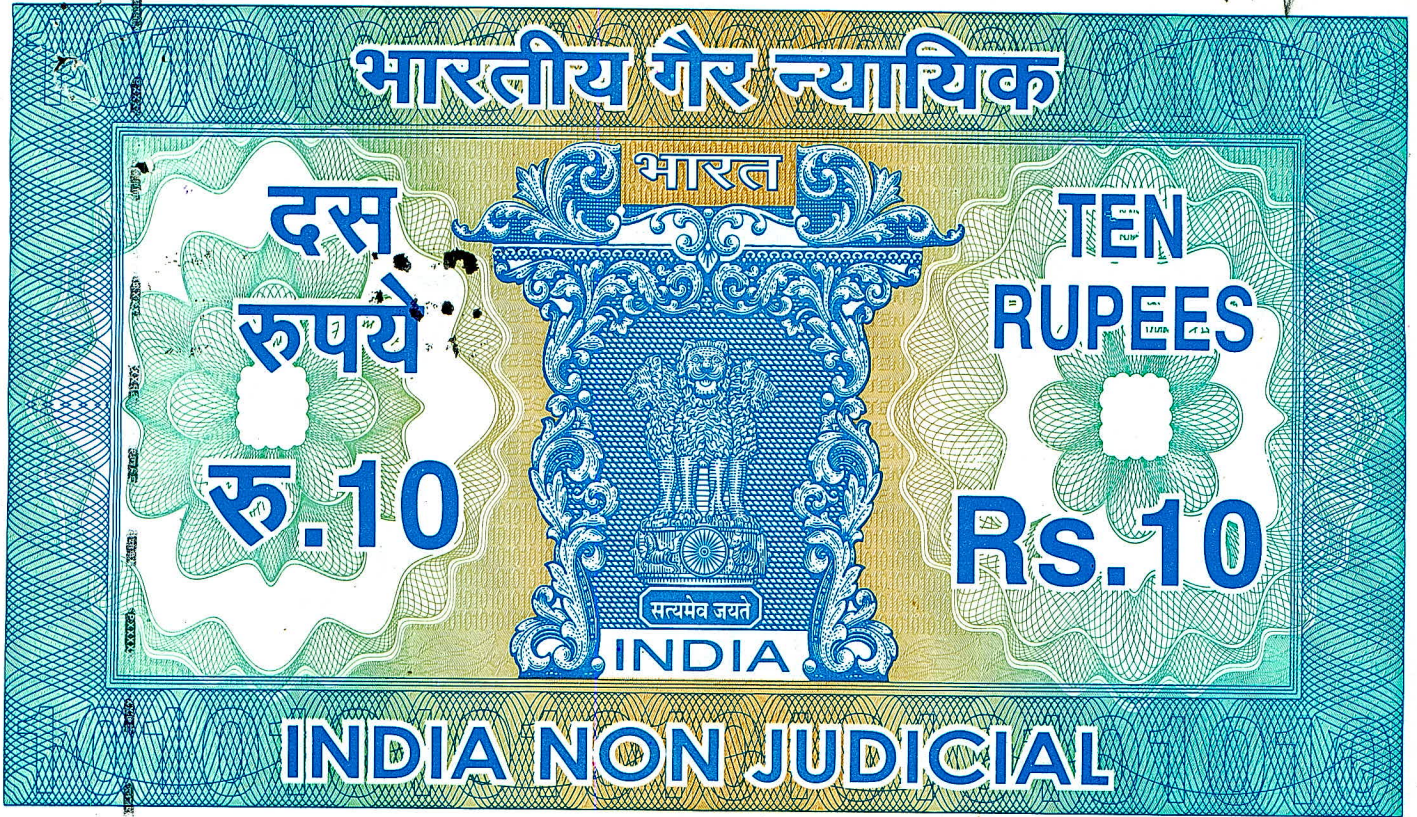

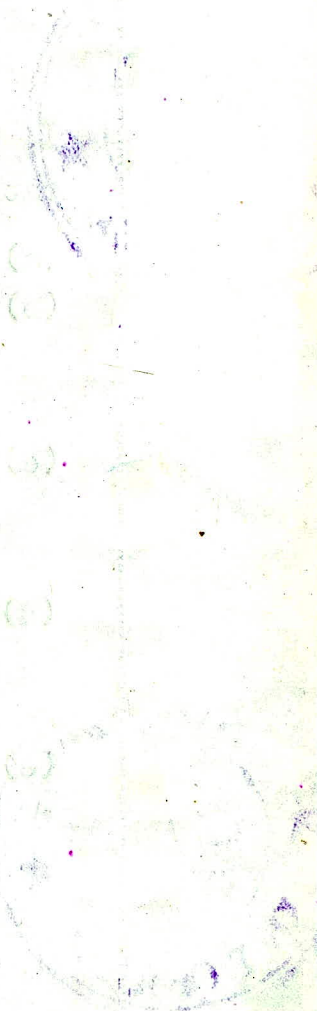

With reference to endt. no. 2069/ XV- Civil dated 26.06.2013 on the above subject, I have to say that Smt. 
