May kindly see the letter, placed below at flag 'A' received from Smt. Pratibha Saxena, Additional Chief Judicial Magistrate, Jaunpur regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family financial year 2006-07, 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that earlier Smt. Pratibha Saxena had submitted the photocopy of statement of her property acquired/ held for the financial year 2007-08 & 2009-10 (flagged 'A-I') but she has not submitted the property statement of the financial year 2006-07 & 2008-09. Thereafter, she was asked vide Court's letter dated 04-06-2011 (flagged 'C') to furnish the movable and immovable property statement of the financial year 2006-07 & 2008-09 .

Now in reply of aforesaid Court's letter she has sent letter (flagged 'A') alongwith the movable and immovable property statement of the financial year 2006-07, 2007-08, 2008-09 & 2009-10.

In this connection it is submitted that Smt. Pratibha Saxena had already submitted the statement of his property acquired/ held up to the financial year 2005-06 which has already been seen by Hon'ble Mr. Justice V. C. Misra the then Administrative Judge Shahjahanpur Judgeship on 11-12-2007 submitted through office note dated 05-12-2007 at flag 'B'.

May, therefore, if approved, the statement for the financial year 2006-07, 2007-08, 2008-09 & 2009-10 along with letter dated 28-07-2011 of Smt. Pratibha Saxena, Additional Chief Judicial Magistrate, Jaunpur be laid before Hon'ble Mr. Justice Sanjay Misra, Administrative Judge, Jaunpur Judgeship for his Lordship's kind perusal and orders?
