It may be recalled that earlier on receipt of Government letter dated 27.04.2010 alongwith enclosures (at flag 'D') an office note dated 21.5.2010 was put up before Learned Registrar (Budget) and on consideration the proposal at 'A' was approved on 29.5.2010 and in compliance of said order a court letter No. 10098/IV-3120/Admin. A dated 23.06.2010 (at flag 'E') was sent to the District Judge, Jaunpur with the request to obtain comments/views of the District Judge, Ghaziabad in the above matter and sent to the court after making your comments for taking necessary action.

From a perusal of photocopy of certificate dated 10.09.2010 of the District Judge, Ghaziabad (at flag 'G') received from the District Judge, Jaunpur through letter dated 14.10.2010, it is evident that an amount of house rent @ of Rs. 735.00 per month from 01.07.2010 to 15.12.2008 was paid to Smt. In this connection it may be submitted that from a perusal of certificate dated Nil (at flag 'B') of the District Judge, Ghaziabad received from District Judge, Jaunpur it is evident that Smt. Saxena has paid Rs. 95,000.00 as house rent for the period from 01.07.2007 to January 2009 @ Rs. 5,000.00 per month for 19 months and an amount of Rs. 12,863/- as house rent @ Rs. 735.00 per month from 01.07.2007 to 15.12.2008 was paid to Smt. Saxena during her posting at Ghaziabad out of the amount of Rs. 95,000.00 – Rs. 12,863.00(earlier paid) = Rs. 82,137.00 is to be paid to Smt. Saxena.
