May kindly see the Dattes dated 14-10-10 of the District Judge, Jaunpur through which he has submitted Certificate issued by the District Judge, Chhazibad in the matter of payment of house rent allowance to Smt Pratibha Saxena, the then Judicial Magistrate Hapur Chhazibad placed below at flag 'A' and 'B'

In the aforesaid Dattes the District Judge Jaunpur has stated that in compliance of order of Honble court a certificate has been obtained from the District Judge, Chhazibad by this office in the matter of payment of house rent allowance from 01-07-2007 to May 2009, to Smt Pratibha Saxena the then Judicial Magistrate, Hapur Chhazibad now posted as Addl Chief Judicial Magistrate, Jaunpur. According to Certificate (at flag 'B') of the District Judge Chhazibad she has been paid house rent allowance Rs 735=0 (at the rate of) per month for the period 01-7-2007 to 15-12-2008. During the period from 16-12-08 to 31-5-09 Smt Pratibha Saxena remain as Self drawing officer and has not drawn any house rent allowance for the period 16-12-2008 to 31-05-09. He has further stated that Smt Saxena has joined in this judgeship on 08-06-2009 as Addl Chief Judicial Magistrate and she is residing in Government residence.

It may be recalled that <sup>previously</sup> earlier an application of Smt Pratibha Saxena, the then Judicial Magistrate, Chhazhabad now posted as Additional Chief Judicial Magistrate, Jaunpur in the matter of payment of house rent received in this court through Government letter dated 27-04-2010 (Htg A-1). On aforesaid application of Smt Saxena an office note dated 21-05-2010 was prepared and after obtaining the order / approval of Learned Registrar (Budget) dated 29-05-2010, a court's letter No 10098/IV-3120/ Admin A dated 23-06-10 (Htg 'D') was sent to the District Judge Jaunpur with the request to obtain comments / views of the District Judge, Chhazhabad in the said matter and the comments so received from the District Judge, Chhazhabad may be forwarded to this court after making your comments for taking necessary action.

In reply of court's letter dated 23-06-10, the District Judge, Jaunpur through his letter dated 14/07/10 (at Htg 'A') has sent his comments along with certificate of the District Judge, Chhazhabad regarding payment of house rent allowance to Smt Pratibha Saxena, to this court for necessary action.

In this connection it may be submitted that from a perusal of photocopy of certificate dated 10-09-2010 of the District Judge, Chhazhabad (at Htg 'B') received from the District Judge, Jaunpur through his

Letter dated 14-12-2010, it is evident that <sup>Revised by</sup> an amount of house rent at the rate of Rs 735=0 per month from 01-7-2007 to 15-12-2008 was paid to Smt Pratibha Saxena when she was posted as Judicial Magistrate, Hubli Coharabad and no amount has been drawn on account of house rent allowance during the period from 16-12-2008 to 31-05-2009 to Smt Saxena as she was posted Self Drawing & disbursing officer at Coharabad.

Through her application dated 03.09.09 (at Hq<sup>o</sup> C<sup>o</sup>) she had claimed house rent allowance difference for the month of June 2007 to June 2009

In this connection it may also be submitted that under the provision contained in para -7 of the G.O NO 6058 / II - 4-05-45 (12) / 91 T.C dated 27-1-2006. There is following provision

(7) आवास / भकान किरया भत्ता
