May kindly see the letter dated 30.5.13 (flagged 'A') received from Sri Taiyab Ahmad, Additional Civil Judge(Sr.Div.), Allahabad regarding Submission of statement of movable and immovable property for the financial years 2010-11 and 2011-12 in prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that from perusal of the property statement for the financial years 2010-11, Sri Ahmad annual gross income from Salary was Rs.6,69,267/- and from this amount he has deposited/invested Rs.2,68,277/- in Saving Bank Account, Rs.75,000/- in PPF, Rs.17,416/- in LIC Rs.45,660/- loan installments , Rs.48000/- in GPF and Rs.1440/- in GIS . The total deductions/investments is Rs.4,55,793/- . Thus a sum of Rs.2,13,474/- was therefore available to him to meet out his family expenditure in whole year.

In the financial year 2011-12, Sri Ahmad annual gross income from salary was RS.16,53,261/- and from this amount he has deposited/invested Rs.7,00,000/- in Saving Bank Account, Rs. 1,00,000/- in PPF, Rs.17416/- in LIC, Rs.45,660/- is Isoan installment, Rs.2,42,570/- in GPF and Rs.3960/- in GI. The total deductions/investments is Rs.11, 99.606 after deductions and investment the rest amount comes to Rs. Rs.5,43,655/- (calculation sheet below) to meet out his family expenditure in whole year.

The aforesaid movable and immovable property statement has been submitted by the officer vide his letter dated 30.5.13(flagged 'A') which was due to be submitted in third financial years 2012-13 i.e. on or before 31.3.13. As such there appears some delay in submitting the aforesaid property statement from the part of officer.

In this connection it is submitted that Sri Ahmad has already submitted his property statement upto financial years 2009-10 which has already been seen by Hon'ble Mr. Justice Vineet Saran, Administrative Judge, Meerut on 1.3.11 at flag 'Z'. The said statement for financial year 2009-10 is at flag 'M'.
