May kindly see the letter, placed below at flag 'A' & 'A-I' received from Sri Taiyab Ahmad, Additional Civil Judge (Sr. Div.), Allahabad regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Taiyab Ahmad had submitted his movable & immovable property statements of the financial years 2012-13 and 2013-14 through his letter dated 30-05-2013 and 25-09-2014 (flagged 'A'). Thereafter he was asked to disclose the details of deductions i. e. Income Tax etc. in the financial years 2012-13 and 2013-14 vide Court's letters dated 12-11-2014 (flagged 'C').

Now, Sri Ahmad has submitted required informations through his letter dated 15-11-2014 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property of the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13, the income from Gross salary is Rs.10,64,181 and from this amount, Rs.4800/- is deducted against GIS, Rs.1,09,791/- against GPF, Rs.1,02,660/- against Income Tax, Rs.17,416/- against LIC and Rs.1,00,000/- deposited in his PPF account in this financial years. The balance of his savings bank account (s) enhanced for Rs.3,28,423/- (including interest.). As such, total deductions /repayment /savings/ investment is Rs.06,63,090/-. Thus, a sum of Rs.04,01,091/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2012-13.

(2) In the financial year 2013-14, the income from Gross salary is Rs.10,38,722 and from this amount, Rs.4800/- is deducted against GIS, Rs.1,11,320/- against GPF, Rs.1,14,973/- against Income Tax, Rs.17,416/- against LIC and Rs.2,10,423/- deposited in his PPF account in this financial years. As such, total deductions /repayment /savings/ investment is Rs.4,58,932/- The balance of his saving bank account (s) is reduced

to Rs.07,51,801/- from its previous year's balance Thus, a sum of Rs.13,31,591/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Taiyab Ahmad has already submitted his property statement for the financial year 2011-12 (statement is at flag 'X') which had already been seen by Hon'ble Mr. Justice Dilip Gupta Administrative Judge, Allahabad at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the the property statement for the financial 2012-13 through letter dated 30-05-2013 and financial 2013-14 through letter dated 25-09-2014 as such, there is no delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letter dated 15-11-2014 (flagged 'A') of Sri Taiyab Ahmad, Additional Civil Judge (Sr. Div.), Allahabad, be laid before Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
