May kindly see the letters, placed below at **flags 'A' & 'B'**, received from Sri Taiyab Ahmad, Additional District & Sessions Judge/F.T.C., Mainpuri regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Taiyab Ahmad has submitted the movable and immovable property statements for the financial years 2014-15 only through his letter dated 05.12.2017 (at **flag 'B'**) whereas he had also submitted the property statements for the financial year 2015-16, as per circular letter dated 13.05.2004. Accordingly, a Court's letter dated 30.01.2018 (at **flag 'C'**) has sent to the District Judge, Mainpuri with the request to kindly ask the officer to furnish the aforesaid information, to the Court at an early date, so that further necessary action may be taken in the matter.

The officer has fulfilled required details through his letter dated 15.02.2018 (at **flag 'A'**).

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2014-15, income from salary is Rs.13,29,781/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,31,101/- against GPF, Rs.1,44,116/- against Income Tax, Rs.17,416/- against premium of LIC policies and Rs.1,50,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.48,052/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.4,95,485/-. Thus, a sum of Rs.8,34,296/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(2) In the financial year 2015-16, income from salary is Rs.13,35,068/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.3,03,165/- against GPF, Rs.1,63,299/- against Income Tax, Rs.17,416/- against premium of LIC policies and Rs.1,50,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.4,14,400/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.10,53,080/-. Thus, a sum of Rs.2,81,988/- was therefore available with him to

meet out the household expenditure of his family consisting of five members in whole of the financial year.

In this connection it is submitted that Sri Taiyab Ahmad has already submitted his property statement upto the financial year 2013-14 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017. He has submitted the movable & immovable property statements for the financial years 2014-15 & 2015-16 vide his letters dated 05.12.2017 & 05.02.2018 (at flags 'B' & 'A' respectively). As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has regretted for late submission and stated that entry in passbook of a/c no.6177000400000391 could not be done after 25.07.2015 because of upgrading the CBS System in bank (as per the bank says) and would be done after 10.02.2018 in his letter dated 05.02.2018(at flag 'D').

May, therefore, if approved, the property statements for the financial years 2014-15 and 2015-16 alongwith letters dated 05.12.2017 & 05.02.2018 (at flags 'B' & 'A' respectively) of Sri Taiyab Ahmad, Additional District & Sessions Judge/F.T.C., Mainpuri be laid before Hon'ble Mr. Justice Rajiv Lochan Mehrotra, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders?
