May kindly see the letters, placed at flags 'A' & 'A-1', received from Km. Afshan, Additional Judge Small Causes Court, Aligarh regarding issuance of 'Identity Certificate' for grant of permission for renewal of Passport.

In her letters, Km. Afshan has stated that she has joined judicial service on 07.01.2004 and is the holder of Passport no. E6025413 since before joining the judicial service, which is valid from 01.01.2004 to 31.12.2013 (copy of Passport is at flag 'B'). She had not visited any foreign country on this passport but in near future there is a possibility of visiting foreign country for which it is essential to extend its validity. Thus, she has requested the Hon'ble Court to grant her permission to extend the validity of her said passport. She has also submitted her declaration & details of her dependent family members along with her four passport sized photographs as per requirement/as per Section 6 (2) of the Passport Act 1967 on an affidavit (flagged 'C').

In this connection, it is submitted that in such matters, 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma is issued, instead of granting permission. The same is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'X'). She has requested for permission from the Court for obtaining/ renewal of Passport. Here is also to noteworthy here that as per reports, placed below, no vigilance/ departmental enquiry is pending against Km. Afshan, she has joined the Judicial service on 07.01.2004 and the Passport which she owns prior to joining the service appears to have been expiring, for which the officer wants to renew/obtain a fresh passport. Here it is also pertinent to mention that Km. Afshan, as stated in the 'Affidavit', had visited Saudi Arabia in the year 2006 for Haj pilgrimage on special passport issued by authorities concerned after obtaining due permission from Hon'ble High Court, Allahabad. (Order of Hon'ble Judge is at flag 'X-1'). Her request is considerable, as she has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Aligarh Judgeship, 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Km. Afshan, Additional Judge Small Causes Court, Aligarh, as requested, for obtaining/ renewal of Passport, with the direction that she should take prior permission of the Court before proceeding abroad?
