May kindly see the letters, placed below flag at 'A' & 'A-1', received from Km. Afshan, Additional District & Sessions Judge (FTC), Kanpur Nagar regarding issuance of fresh 'Identity Certificate' for obtaining new Passport.

In her letters, Km. Afshan has stated that she was issued an 'Identity Certificate' dated 28.11.2013, in connection with her application dated 01.07.2013 (flagged 'Z'), for obtaining/renewal of passport but due to the lapse of renewal period, her passport got expired. Thereafter, she was again granted permission for obtaining new passport vide the Court's letter dated 25.04.2014 (flagged 'Z-1') on her application dated 02.04.2014 but due to some inevitable circumstances, she could not apply for passport in time and the term of the certificate has expired. She has also stated that she may have to visit foreign country in future for which passport is required. She has also furnished four passport size photographs of herself and required details and declarations on an 'Affidavit' as per G.O. and Section 6 (2) of Passport Rules, which may kindly be seen at flag 'B'. Her dependents are Sri Abdul Ghaffar (Father) and Smt. Siddiqua (Mother). She has, therefore, requested for issuance of fresh 'Identity Certificate' in her favour for obtaining new Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). Earlier, as per approval dated 25.11.2013 of Hon'ble Administrative Judge, Aligarh (flagged 'X'), 'Identity Certificate' dated 28.11.2013 was issued in her favour (office copy is at flag 'D'), but as she has requested for issuance of fresh 'Identity Certificate' due to the reason that she could not apply for new passport within the allotted time, her request may be considered. Here it is also to submit that as per reports, placed below, no vigilance/ departmental enquiry is pending against Km. Afshan. It is also pertinent to mention here that Km. Afshan, as stated in the 'Affidavit', had visited Saudi Arabia in the year 2006 for Haj pilgrimage on special passport issued by authorities concerned after obtaining due permission from Hon'ble High Court, Allahabad (Order of Hon'ble Judge is at flag 'X-1'). Her request is considerable, as she has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice S.S. Chauhan, Administrative Judge, Kanpur Nagar and if His Lordship approves, the 'Identity Certificate' at flag 'E' be issued, in duplicate, in favour of Km. Afshan, Additional District & Sessions Judge (FTC), Kanpur Nagar as requested, for obtaining Passport with the direction of the Court that she may now apply for issuance of Passport within due time and she should take prior permission of the Court before proceeding abroad?
