May Kindly see the letter, placed below at flag 'A', received from Km. Afshan, Civil Judge (Jr. Div.), Hawali, Saharanpur regarding grant of permission to appear in first year examination of correspondence course of LL.M. from Kurukshetra University, Kurukshetra.

In her letter, Km. Afshan has stated that she has taken admission in two years LL.M. course via correspondence from Kurukshetra University, Kurukshetra, Haryana in the year 2007 (Session 2007-08). The proposed date for the examination is May-June 2008. She has also furnished copy of Admission card (flag 'Z') and has requested that she may be allowed to appear in first year examination of LL.M. (Session 2007-08).

In this connection, it is submitted that a judicial officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No. 24/1066-Appointment (B) dated 21.08.1967 (copy at flag X), subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours. The Head of the Department should verify from the educational institutions concerned the hours during which classes will be held and permission should be given only in cases where these hours are clearly beyond the prescribed office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his/her normal work or that public work suffers, in any way.

In the instant case, it is to mention that the officer has joined the judicial service on 07.01.2004. She has requested to appear in LL.M. first year examination from Kurukshetra University, Kurukshetra and as the course is through correspondence, there seems to be nothing objectionable, if she will be granted the permission, as requested, subject to the conditions mentioned above. However, acceptance of her request is on the discretion of the Court.

May, therefore, if approved by Hon'ble The Chief Justice, permission be accorded to Km. Afshan, Civil Judge (Jr. Div.), Hawali, Saharanpur to appear in LL.M.
