May Kindly see the letter, placed below at flag 'A' (page 54/C), received from Km. Afshan, Additional Chief Judicial Magistrate, Barabanki regarding grant of permission to appear in 2nd year examination of LL.M. of Kurukshetra University, Kurukshetra; Haryana, scheduled to be held in May-June 2010.

Km. Afshan in his letter has stated that he had taken admission in two year's LL.M. course via correspondence from Kurukshetra University, Kurukshetra, Haryana in the year 2007 (Session 2007-08) and Hon'ble Court was pleased to grant her permission to appear in LL.M. 1st year examination. Now, she has to appear in LL.M. 2nd year examination, proposed date of the same is May-June 2010. She has also submitted a copy of ^{the} ~~the~~ mark sheet of 1st year examination (flag 'B') and has requested that she may kindly be allowed to appear in the above mentioned second year examination (Session 2009-2010).

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 07.01.2004. Earlier, vide Court's order dated 02.01.2008 (flag 'C'), she was allowed to appear in first year examination (Session 2007-08) through correspondence course from Kurukshetra University, Kurukshetra, Haryana. Now, she may be granted permission to appear in 2nd year examination of the same course, if the Court so desires. It is further submitted that a judicial officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No. 24/1066-Appointment (B) dated 21.08.1967 (copy at flag X), subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble The Acting Chief Justice, permission be accorded to Km. Afshan, Additional Chief Judicial Magistrate, Barabanki to
