May kindly see the letter, placed below at **flag 'A'**, received from Sri Kushal Pal, Additional District & Sessions Judge, Agra regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

- (1) In the financial year 2014-15 & 2015-16, income from salary is Rs.30,25,273/- and from this amount, Rs.2,68,800/- is deducted against GPF, Rs.9,600/- against GIS, Rs.4,47,232/- against Income Tax, Rs.66,000/- against PLI, Rs.10,900/- against RD, Rs.28,000/- against SIP and Rs.1,92,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.4,34,826/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.14,57,358/-. Thus, a sum of Rs.15,67,915/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2014-15 & 2015-16.

In this connection it is submitted that Sri Kushal Pal has already submitted his property statement upto the financial year 2013-14 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Agra at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017. He has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 vide his letter dated 11.12.2017 (at **flag 'A'**). As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has regretted with the folded hands for late submission of aforesaid statements in his letter dated
