May kindly see the letter, placed below at flag 'A', received from Sri Kushal Pal, Additional District & Sessions Judge, Agra regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13 & 2013-14, the income from salary is Rs.21,10,856/- (including allowances & arrears) and from this amount, Rs.9,600/- is deducted against GIS, Rs.2,14,644/- against Income Tax, Rs.1,92,000/- against GPF, Rs.66,000/- against premium of postal Life Insurance, Rs. 14,000/- against S.I.P. mutual fund, Rs.10,900/- against S.I.P. UBI and Rs.94,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.9,73,711/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.15,74,855/-. Thus, a sum of Rs.5,36,001/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2012-13 and 2013-14.

It is pertinent to mention here that his Father has retired from the post of District & Sessions Judge and his monthly income is Rs.67000/-.

In this connection it is submitted that Sri Kushal Pal has already submitted his property statement upto the financial year 2011-12 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Dinesh Gupta, the then Administrative Judge, Unnao on 04.10.2013 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-13 & 2013-14 in its

next financial year i.e., 2014-15 up to March 2015. He has submitted the movable and immovable property statement for the financial year 2012-13 & 2013-14 vide his letter dated 07.12.2015. As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has regretted for late submission of property statements in his letter dated 07.12.2015 (flag 'A').

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letter dated 07.12.2015 (at flag 'A') of Sri Kushal Pal, Additional District & Sessions Judge, Agra be laid before Hon'ble Mr. Justice Shashi Kant Gupta, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
