May kindly see the letter, placed below at flag 'A' & 'A-1', received from Sri Humayun Rasheed Khan, Additional Chief Judicial Magistrate, Aligarh regarding submission of statement of movable & property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering into Judicial Service and financial years 2006-07 & 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Humayun Rasheed Khan had submitted his consolidate movable property statement for the calendar year 2010 through his letter dated 17-09-2010 (flagged 'A-II') which was not according to circular letter dated 13-05-2004. Thereafter he was asked to send his movable and immovable property statements at the time of entering into Judicial Service and financial years 2006-07 & 2007-08, 2008-09 & 2009-10 vide court's letter dated 04-01-2011 (flagged 'C-1'). In reply of Court's letter dated 04-01-11 Sri Humayun Rasheed Khan has sent letter dated 17-01-2011 (flagged 'A-1'), by which he has submitted the immovable & immovable property statement at the time of entering into Judicial Service and 2006-07 & 2007-08, 2008-09 & 2009-10. Thereafter he was asked to furnish some informations of the aforesaid property statements, vide court's letter dated 10-05-2011 flagged 'C-II').

Now in reply of Court's letter dated 10-05-11 Sri Humayun Rasheed Khan has sent letters dated 03-05-2011 (flagged 'A' & 'A-1'), by which he has submitted the immovable & immovable property statement at the time of entering into Judicial Service and financial years 2006-07 & 2007-08, 2008-09 & 2009-10 a and also given the reply of the Court's letter lated 10-05-2011, which is at flag 'A'.

In this connection it is further submitted that the officer concerned has joined the U.P. Judicial Service on 15-06-2006
